MEMORANDUM OF AGREEMENT between THE MUNICIPALITY OF BURAUEN and THE EASTERN VISAYAS STATE UNIVERSITY

KNOW ALL MEN BY THESE PRESENTS

This **MEMORANDUM OF AGREEMENT** made and entered into at the Municipality of Buruaen, Leyte, Philippines on October 29, 2028 by and between the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** of Tacloban City represented by its President, **DR. DOMINADOR O. AGUIRRE, JR.**, herein referred to as **EVSU**;

And

The LOCAL GOVERNMENT UNIT OF BURAUEN, represented by its Municipal Mayor, HON. JUANITO E. RENOMERON, hereinafter referred to as the DEVELOPMENT PARTNER,

WITNESSETH

WHEREAS, EVSU is a higher learning institution mandated to develop the potential of Region VIII.;

WHEREAS, the ESVU is mandated with four major functions: namely, Instruction, Research, Extension and Production;

WHEREAS, EVSU implements its Extension Services function across colleges at the Main Campus in Tacloban City and its Satellite Campuses, namely: EVSU-Ormoc City Campus (OCC); EVSU Tanauan Campus; EVSU Carigara Campus and EVSU Burauen Campus;

WHEREAS, EVSU implements its Extension Services function across colleges at the Main Campus in Tacloban City and its Satellite Campuses, namely; EVSU-Ormoc City Campsus (OCC); EVSU Tanauan Campus, EVSU-TC, EVSU Carigara Campus (ECC), EVSU Burauen Campus (EBC);

WHEREAS, LGU BURAUEN, has recently created a college known as BURAUEN COMMUNITY COLLEGE to cater to the needs of BURAUEN and the nearby towns;

WHEREAS, LGU BURAUEN, cognizant of the existence of the Extension Services of EVSU-Main Campus, would like to avail of the technical competence of its Institutional Planning & Development Office (IPDO) in connection with the development/improvement of its school facilities specifically the construction of its school building and laboratories at its proposed site in BURAUEN, Leyte;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE 1 POINTS OF AGREEMENT

- 1. The parties shall consult each other as regards the overall implementation of the partnership to be conducted in the Municipality of Burauen, Province of Leyte.
- 2. The parties shall help each other source out resources and or materials to be used in the Partnership Program.

ARTICLE II RESPONSIBILITIES OF EVSU

- EVSU shall provide its available skills, expertise and technical manpower resources
 who will be involved specifically on the engineering and architectural design of
 the buildings and laboratories; shall provide the design for such building and
 laboratories and shall conduct regular supervision and inspection during the
 construction period;
- 2. **EVSU** shall further inform in writing and must meet with representatives of the development partner on a regular basis to discuss the progress of the partnership;
- EVSU shall assist the DEVELOPMENT PARTNER in the various preparations and requirements needed in the establishment of the proposed Community College to be sponsored by the LGU of Burauen;

ARTICLE III RESPONSIBILITIES OF THE COMMUNITY BENEFICIARY

- 1. The **DEVELOPMENT PARTNER** shall assist and facilitate the implementation of the Extension Services Program of EVSU;
- 2. The **DEVELOPMENT PARTNER** shall assure the safety of the EVSU personnel in the conduct of community development activities in the locality;
- 3. The **DEVELOPMENT PARTNER** shall provide the necessary equipment, supplies and other required resources to carry out the above project.
