



## MEMORANDUM OF UNDERSTANDING

between

**OUR LADY OF FATIMA UNIVERSITY**  
Marulas, Valenzuela City, Philippines

and

**EASTERN VISAYAS STATE UNIVERSITY**  
Arch. Lino R. Gonzaga Avenue,  
Tacloban City, Philippines

Our Lady of Fatima University and Eastern Visayas State University wishing to promote cooperation between the two institutions, agree to explore:

- a. On-the-job training;
- b. Observation and exposure visits;
- c. Development of joint research activities;
- d. Provision of resource experts;
- e. Exchange of information and materials;
- f. Any other activities viewed to be mutually beneficial.

The terms of cooperation for each specific activity implemented under this Memorandum of Understanding (MoU) shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity and will be the subject of separate agreements.

This MoU becomes effective from the day the representatives of both institutions affix their signatures below, and will continue for an initial period of three years, whereupon it shall be reviewed and may be extended by the mutual written agreement of both institutions. This MoU may be revised through the mutual agreement of both institutions and may be terminated by either party upon giving six months' written notice signed by the presiding officer of the notifying party.

Any use of the names 'Our Lady of Fatima University' or 'Eastern Visayas State University' including any of its departments, programmes or logos, relating in any way to the activities described in this MoU, shall be subject to prior written approval.

The administration of this MoU will be the responsibility of the identified and relevant offices specified in the terms of reference to be established per project to be undertaken under this MoU by and between Our Lady of Fatima University and Eastern Visayas State University.
