Conference Overview

The Department of Agricultural and Applied Economics (DAAE) in partnership with the Applied and Agricultural Economics Society, Inc. (AAES) will hold the **2023 International Conference on Applied and Agricultural Economics (***AECON 2023***)** with the theme, "Advancing Knowledge and Forging Cooperation Towards Sustainable Food and Agricultural Development". The conference will be held on 19 – 20 October 2023 via Zoom. *AECON 2023* is an endeavor of DAAE and AAES to further the dialogue on the role and challenges faced by the food and agriculture sector on sustainable development while taking into account population growth.

As the need to feed an increasingly expanding world population (estimated by the UN to reach over 9 billion by 2050), food and agriculture are globally recognized as a vital sector of the world economy. Scholarly research has identified and debated the numerous consequences of population growth on development, most critically on the sustainability of supporting life on planet earth. In fact, the new set of sustainable development goals (SDGs) is based on an agenda that explicitly declares in its opening preamble, "a plan of action for people, planet, and prosperity".

Anchored on this global agenda, the DAAE and AAES successfully hosted the 2019 International Conference on Applied and Agricultural Economics (*AE*CON 2019), with the theme, "Agricultural Economics at the Frontier: Learning from the Past and Shaping the Future of the Global Agricultural Economy". This time around, with AECON 2023, the dialogue would focus on advancing knowledge and forging cooperation towards sustainable food and agricultural development.

The overall objective of the conference is to enable stakeholders to cultivate their interest on food and agriculture to dialogue on issues, explore options, and nurture partnerships. Specifically,



through the exchange of knowledge and experience, the conference will help key stakeholders in the following:

- a. For the academe and development research agencies: expert views, industry feedback, and agricultural group concerns will help inform its instruction, research, and extension thrusts. They will be able to determine if their current efforts are effectively serving the needs of society in their pursuit for a sustainable future earth.
- **b.** For policy makers: a platform for dialogue on issues and concerns, listening for solutions, and exchange of ideas with key stakeholders of food and agriculture.
- **c.** For relevant industry players: an opportunity to explore the available knowledge, capacity, as well as technology that can help their respective industries' growth potentials in an earth friendly way.
- d. For farmers, fishermen, livestock growers, and respective groups or associations, including cooperatives: an avenue to voice a realistic view of their concerns regarding food and agriculture, while also getting a chance to tap support from academe, development research institutions, policy makers, and industry.
- e. **For students:** a first-hand look at the complex challenges under a large theme of "Food and Agriculture" from key experts and stakeholders involved in the sector.

The Abstract must be written in English and shall be limited to **one page** [letter size sheet] containing **300 words only**.
