Lino R. Gonzaga Ave., Tacloban City from **June 10 to 18, 2024 from 09:00 a.m. to 04:00 p.m**.

Bids, in three (3) copies, shall be placed together with the corresponding qualification documents and bid bond equivalent to 10% of the total bid amount, in a sealed and signed envelope indicating the Lot No., Name, Address and Contact Numbers.

Unsigned bid forms, bids lower than the floor price, those without the corresponding bid bond and qualification documents shall automatically be disqualified.

All expenses incidental to the withdrawal of the properties shall be borne by the winning bidder.

The EVSU Disposal Committee reserves the right to reject any or all of the bids with or without cause, to waive any defect and to award the bidder whose bid is the most advantageous to the government.
