We wish to inform you that your bid price in the amount of **Seven Million Nine Hundred Eighty Thousand Three Hundred Fifty-Seven Pesos and 88/100 (Php7,980,357.88)** for **IB-2024-07-15 RENOVATION OF THE EVSU-SLS AUDIO VISUAL HALL, OLD LIBRARY FUNCTION ROOM, ENGINEERING BUILDING ROOM 301, 302, 303, AND 304 AS EVSU SMART CAMPUS E-LEARNING CENTERS**, was recommended by the Bids and Awards Committee (BAC) of the EVSU-Main Campus as the Lowest Calculated and Responsive Bid (LCRB) for the said contract, after proper evaluation by its Technical Working Group (TWG), and approved/ratified by the EVSU-BAC and the HOPE through its Authorized Representative per BAC Resolution No. 438, s. 2024 adopted on September 10, 2024; and therefore, this procurement is hereby awarded in favour of your company subject to pertinent provisions of Republic Act No. 9184 and its IRR and other policies promulgated by competent authority/ies.

- 5) Equipment Utilization Schedule;
- 6) Contractor's All-Risk Insurance (CARI);
- 7) and other acceptable tools of project scheduling.

Failure to provide the abovementioned documents shall constitute sufficient ground for cancellation of the award and forfeiture of the bid security.

Further, your acceptance of this **Notice of Award (NOA)** binds your company with the University based on the bidding documents and relevant documents which were the basis in the conduct of bidding and evaluation of the said procurement, pending the negotiation and execution of the formal contract to be signed between your authorized representative and the undersigned as the authorized representative of the HOPE, within ten (10) days from your acceptance of this NOA, consistent with relevant laws, rules and regulations. Thus, it is further informed, that failure of both parties to execute the required Contract within the said period shall be a sufficient ground of non-issuance of the Notice to Proceed (NTP).





Our staff/end-user will coordinate with you for the details of the requirements. You will be given a copy of the relevant documents as soon as these are completely processed. The corresponding contract shall be signed between the parties afterwards.
