Failure to provide the abovementioned documents shall constitute sufficient ground for cancellation of the award and forfeiture of the bid security.

Further, your acceptance of this **Notice of Award (NOA)** binds your company with the University based on the bidding documents and relevant documents which were the basis in the conduct of bidding and evaluation of the said procurement, pending the negotiation and execution of the formal contract to be signed between your authorized representative and the
