Thus, it is further informed, that failure of both parties to execute the required Contract within the said period shall be a sufficient ground of non-issuance of the Notice to Proceed (NTP).

Our staff/end-user will coordinate with you for the details of the requirements. You will be given a copy of the relevant documents as soon as these are completely processed. The corresponding contract shall be signed between the parties afterwards.




