

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

The **PHILIPPINE NORMAL UNIVERSITY**, a state university, with its principal office at Taft Avenue, Ermita, Manila represented by its President, **DR. BERT J. TUGA**, hereinafter referred to as **PNU**.

-and-

The **EASTERN VISAYAS STATE UNIVERSITY**, with principal address at Salazar St., Downtown Tacloban City, Leyte, represented by its President, **DOMINADOR O. AGUIRRE, JR., DM**, herein referred to as **EVSU**.

WITNESSETH:

WHEREAS, the PNU, in its existence as a Higher Education Institution is bound to perform four major functions, namely INSTRUCTION, RESEARCH, PRODUCTION AND EXTENSION;

WHEREAS, in carrying out its Research and Extension mandates, the University needs to partner with organizations which undertake social research to become society's strong partner in the protection and conservation of the country's environment and natural resources, and community development;

WHEREAS, the Eastern Visayas State University, created by virtue of Republic Act 9311 (An Act Converting the Leyte Institute of Technology (LIT) in the Province of Leyte into a State University to be Known as the Eastern Visayas State University and Appropriating Funds Therefor), has a four-fold function in providing technological and professional instruction and training in engineering, architecture, fishery, agriculture, science, education, commerce, trade, and related courses;

WHEREAS, EVSU, a public institution and one of the top universities in Region 8, is working for the promotion of the use of Mother Tongue in the teaching of Mathematics, also needs partner institution in the spirit of collaboration;

WHEREAS, other areas of cooperation that may stem from this partnership may include, subject to mutual consent, programs and activities that may be beneficial to fostering and developing cooperative relationship, such as, training of faculty members, organization of seminars, sharing of resources and other facilities;

WHEREFORE, foregoing premises considered, the PNU and the EVSU agree and bind themselves to jointly venture into mathematics and language-related researches, such as, but not limited to the study on "Exploration of the Meaning of Lived Experiences among Mathematics Teachers towards MTB-MLE Module Development in the Teaching of Mathematics"; and other similar studies in the future.



Article I
Responsibilities of PNU

1. Allow its faculty to join research within its program of activities as long as it will not greatly affect instruction.
2. Allow the use of facilities and instruments necessary in the conduct of research.
3. Provide (if available) necessary manpower that could assist in the conduct of research.


Article II
Responsibilities of EVSU


1. Provide opportunities for PNU faculty to be involved in research whenever it is within its program of activities;
2. Allow the use of facilities and instruments necessary in the conduct of research;
3. Provide (if available) necessary manpower that could assist in the conduct of research; and
4. Provide release time (deloading) to the faculty involved in the research for the duration of the project.

Article III
Effectivity

This Memorandum of Agreement shall take effect upon signing hereof by both parties and shall remain valid and in force until the end of December 31, 2021.


