Activity Title: **ANNUAL PAASE MEETING AND SYMPOSIUM (APAMS) 2024**

KNOW ALL MEN AND WOMEN BY THESE PRESENTS:

This Agreement is entered into and executed this ____ day of _____, 2024 by and between:

The **PHILIPPINE-AMERICAN ACADEMY OF SCIENCE & ENGINEERING (PAASE)**, a non-profit international and professional organization composed of scientist and engineers of Philippine descent who have distinguished themselves in scholarly and research related activities with postal address at c/o PAASE Foundation Philippines Inc., at the Marine Science Institute, UP Diliman, Quezon City, Philippines herein represented by its President **DR. GLADYS CHERISSE J. COMPLETO**, who is duly authorized to represent it in this agreement, hereinafter referred to as **PAASE**;

and

The **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**, a state higher education institution duly organized and existing under Philippine Laws, with principal office located at Archbishop Lino R. Gonzaga Avenue, 6500 Tacloban City, Leyte, Philippines, represented by its President, **DR. DENNIS DE PAZ**, herein referred to as **EVSU**;

Which may collectively be referred to as the "**PARTIES**" for the implementation of the above-mentioned activity;

WITNESSETH

WHEREAS, **PAASE**, aims to promote the advancement of science, engineering, engineering and technology, encourage collaborative work among scientist and engineers of Philippine descent in research and development through scholarly and scientific endeavors; support efforts that advance science and technology; and recognize and honor the achievements of scientist and engineers of Philippine descent;

WHEREAS, **PAASE** are organizing the "Annual PAASE Meeting and Symposium (APAMS) 2024" which will be held from July 20 to 22, 2024, with the theme "*Technological Innovations in Disaster Risk Reduction and Management (DRRM) Towards Resiliency*"

WHEREAS, **EVSU**, to foster honor and excellence in serving its mandate as the leading university in technical and professional education;

WHEREAS, all parties have expressed their mutual interest in collaborating for the upcoming **Annual PAASE Meeting and Symposium (APAMS) 2024**;

WHEREAS, the Annual PAASE Meeting and Symposium (APAMS) 2024 will take place in Tacloban City, at the Eastern Visayas State University;

NOW, THEREFORE, in consideration of the above-mentioned factors, the parties involved have jointly agreed to implement a coordinated plan aimed at achieving their shared objectives as follows:

I. OBJECTIVES

- a. To foster collaboration among Filipino Scientists.
- b. To promote regional S&T innovation.
- c. To promote EVSU as an institution that fosters honor, service, and excellence.
- d. To showcase PAASE's and EVSU's research contributions.
- e. To encourage cross-border partnerships.
- f. To empower young researchers and students.
- g. To strengthen policy support.
- h. To enhance science communication and public engagement.
- i. To provide a platform for showcasing EVSU's Programs related to the theme of the event, including opportunities of research partnerships with PAASE

II. RESPONSIBILITIES

- a. PAASE and EVSU as co-organizers of the 44th APAMS.
- b. PAASE and EVSU to co-create and implement the program and activities of the 44th APAMS.
- c. PAASE to lead in securing other partners of the 44th APAMS.
- d. EVSU to provide venue and its amenities, housing to the special guests, logistical support, as well as assistance with preparation and implementation of the event including services of required offices and staff.
- e. EVSU to constitute corresponding conference committees for the conduct of the 44th APAMS.
- f. Inclusion of EVSU's promotional materials in the conference participant kit, ensuring visibility throughout the event.
- g. Placement of EVSU's logo on 44th APAMS official event banners, backdrops, and signage.
- h. Recognition of EVSU in all APAMS 2024 marketing collaterals, including the official website, conference program, and other printed materials.

III. MODIFICATION TO THE MOU

This MOU may be amended with the mutual written consent of the parties. All parties are entitled to clarify, modify, or vary the terms and conditions of the said agreement provided that it is done in good faith and in writing and is approved and signed by all concerned parties.

IV. EFFECTIVITY AND TERMINATION OF MOU

This agreement shall take effect upon signing of the parties. For the termination of the whole Agreement, either party may propose such to the other by serving a written notice, at least thirty (30) days prior to the proposed termination of this Agreement.
