WITNESSETH:

WHEREAS, as per Article II Section I of the By-Laws of the Eastern Visayas Consortium for Industry, Energy, Emerging Technology Research and Development (EVCIEERD), its objective is to promote industry, energy and emerging technology research, development, and extension (RDE) in Eastern Visayas;

WHEREAS, the multi-dimensional character of industry, energy and emerging technology research and development necessitates collaboration between and among institutions and agencies which are stakeholders in research in these areas;

WHEREAS, as per Article III Section I of the By-Laws of EVCIEERD, membership in the Consortium shall be open to academic institutions, government institutions, and nongovernment organizations;

WHEREAS, the major stakeholders in industry, energy and emerging technology research and development in Region VIII recognize the need to collaborate to be able to share resources, expertise, and facilities aligned with the PCIEERD framework;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I. The Board of Directors hereby grants regular membership status to:

- 1. COMMISSION ON HIGHER EDUCATION REGIONAL OFFICE 8 (CHEDRO8);
- 2. PHILIPPINE CHAMBER OF COMMERCE AND INDUSTRY TACLOBAN, LEYTE, INC. (PCCI-TLI); and,
- 3. UNIVERSITY OF THE PHILIPPINES VISAYAS TACLOBAN COLLEGE (UPVTC)
- ARTICLE 2. As per Article III Section 3 of the By-Laws of EVCIEERD, the new members CHEDRO8, PCCI-TLI, and UPVTC are granted the right:
 - a. To exercise the right to vote on all matters relating to the affairs of the Consortium:
 - b. To be eligible to any elective or appointive office of the Consortium;
 - c. To participate in all deliberations/meetings of the Consortium;
