THIS AGREEMENT, entered this **18th day of August, 2023**, by and between **Atma Jaya Catholic University of Indonesia (AJCUI)** and **Eastern Visayas State University**.

WITNESSETH THAT:

Atma Jaya Catholic University of Indonesia (AJCUI) and **Eastern Visayas State University (EVSU)** with the objective of facilitating mutual friendship, academic research and educational cooperation between two institutions, hereby conclude this memorandum.

1. Purpose

Atma Jaya Catholic University of Indonesia and **Eastern Visayas State University** will cooperate in promoting both academic research and enhancing educational opportunities for both institutions.

This memorandum has been made in order to facilitate mutual friendship, academic research and educational cooperation between these two institutions. This memorandum will provide a general and common framework for any different further agreements that will be made on specific forms of mutual cooperation.

2. Scope of Activities of Collaboration

In order to promote the cooperation prescribed in article 2, these two institutions may undertake various activities such as those listed below.

- a) Exchange of undergraduate and graduate students;
- b) Exchange of faculty members and researchers;
- c) Joint research activities;
- d) Exchange of academic, scientific and cultural materials and information;
- e) Other kinds of collaboration proposed and agreed upon by both Parties;

The cooperation between both parties shall not necessarily be limited to these activities, but also other activities can be included in the cooperation. Any specific activity developed under this memorandum shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals.

3. Amendments

Amendments to this memorandum may be made upon mutual agreement of these two institutions.

4. Financial Commitments and Obligations

This memorandum shall not bind either institution to any financial commitment. All financial arrangements will be negotiated in a written mutual consent for each specific case.



5. Use of Name

None of the parties shall use the name, logo, likeness, trademarks, image, or other intellectual property of either of the other parties for any advertising, marketing, endorsement or any other purposes without the specific prior written consent of an authorized representative of the other party as to each such use. Home Institution may refer to the affiliation with AJCUI in public information materials regarding the relevant Program. AJCUI reserves the right to review and request modification of Home Institution's reference to AJCUI as necessary. Home Institution may refer to the affiliation with AJCUI in its brochures and other public information materials having to do with the Program.



6. Term of Validity and Termination

This memorandum shall remain in force for a period of five (5) years beginning the date of signing and it shall be automatically renewed unless either party gives the other party written notice of its desire to either terminate or revise this memorandum twelve (12) months prior to the termination of a given five years period.
