This Memorandum of Understanding is made and entered into by and between:

The **UNIVERSITAS MUHAMMADIYAH SURABAYA**, a private higher education institution organized under the laws of Indonesia, with its principal office located at the Jln. Sutorejo, No. 59, Surabaya, East Java, Indonesia and represented herein by its Rector, **Dr. dr. Sukadiono, M.M.** For brevity and for purposes of this Agreement, Universitas Muhammadiyah Surabaya shall hereinafter be referred to as "UMSurabaya";

The **EASTERN VISAYAS STATE UNIVERSITY**, a higher education institution organized under the laws of the Philippines, with its principal office located at Lino Gonzaga Avenue, Tacloban City and represented herein by its President, **Dr. Dennis C. de Paz**. For brevity and for purposes of this Agreement, Eastern Visayas State University shall hereinafter be referred to as "EVSU".

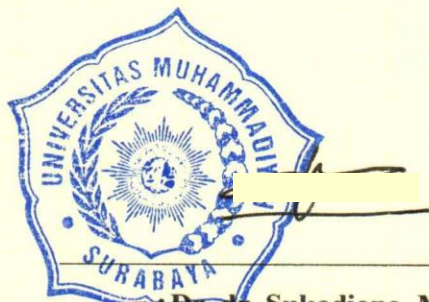
### WITNESS THAT:

UMSurabaya and EVSU, with the objective of facilitating mutual friendship, and international academic cooperation, between the two universities, hereby conclude this MOU to wit:

1. UMSurabaya and EVSU will cooperate in promoting global learning to empower their faculty and bolster educational opportunities for their students.
2. Two institutions resolve to exercise reasonable efforts to promote the following programs:
  - a. Exchange of students;
  - b. Exchange of faculties, staff, and researchers;
  - c. International Learning Sessions among Visiting Professors and Visiting Lecturers;
  - d. Exchange of academic, information, and publications;
  - e. Joint research activities;
  - f. Summer school/ Winter school/short-term program participation
  - g. Joint organizers of international research conferences
  - h. Other activities mutually agreed upon by both parties.

3. The implementation of exchange based on this agreement shall be separately negotiated and determined by both institutions.
4. Nothing shall diminish the full autonomy of either institution nor will any constraint or financial obligation be imposed by either upon the other in carrying out the agreement.
5. This MOU shall become effective upon completion of signatures from various representatives of the two universities, and will be effective for a period of five (5) years, and will be subject to renewal. Hereby making the MOU duration: from July 2023 to July 2028.

7. Should either university wish to terminate this MOU, a written note should be given six (6) months prior to the desired termination date.
8. Amendments to this MOU may be made by mutual written consent of the two universities.
9. This MOU shall not bind either institution to any financial commitment. All discussions of funding and other financial concerns are reserved for the MoAs of the specific programs, subject to the availability of resources.
