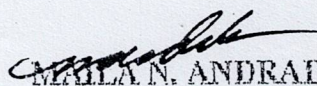
WHEREFORE, on motion of Honorable Jerry S. Uy, jointly seconded by all Honorable Members present, the Sangguniang Palungsod

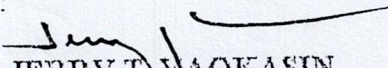
RESOLVE FURTHER, to furnish a copy of this Resolution to Her Honor, City Mayor Cristina G. Romualdez, for appropriate action;
