#### KNOWN ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF UNDERSTANDING sets for the terms and understanding between the Local Government Unit, Municipal Social Welfare and Development Office, Babatngon, Leyte, represented by its Municipal Mayor, HON. MARIA FE G. RONDINA, with principal office at the Municipality of Babatngon, Leyte, herein referred to as "LGU".

And

The Eastern Visayas State University, College of Technology, represented by its President, DOMINADOR O. AGUIRRE, IR. D.M., with principal office at EVSU Campus, Quarry District, Tacloban City, herein referred to as "EVSU".

#### WITHNESSETH:

WHEREAS, the increasing number of Out of School Youths in some communities is a great manifestation of intergenerational cycle of poverty.

WHEREAS, given this situation, agencies of government were called to initiate programs at contributing to the rehabilitation and rebuilding of lives, communities, livelihood assets, infrastructures and the economy of areas below the poverty threshold.

WHEREAS, the EASTERN VISAYAS STATE UNIVERSITY (EVSU), in fulfillment to its mandate to help empower communities by providing the needed technological and profound expertise of the university through the Extension Services Programs; and its effort to help contribute in the rehabilitation and refullding programs and government has to collaborate with various local/national government agencies.

WHEREAS, the LGU-MUNICIPAL SOCIAL WELFARE & DEVELOPMENT OFFICE, the lead agency in social protection, welfare and development in the local setting, also contributes to poverty reduction and empowerment through the provision of appropriate interventions and the promotion of the rights and welfare of the disadvantaged through local and national policies, programs, projects and services, implemented with or through the local government units (LGUs), government organizations (GOs) and other members of the civil society.

WHEREFORE, in the spirit of unity and development and to empower young lives of the Municipality of Babatngon, Leyte, EASTERN VISAYAS STATE UNIVERSITY, College of Technology, enters into this Memorandum of Understanding with the LGU-Municipal Social Welfare and

Development Office, Babatngon, Leyte, in the implementation of the Skills Training for the OSYs in their municipality.

NOW THEREFORE, for and in contribution of the aforementioned, the LGU and EVSU have agreed on the following:

# I. POINTS OF AGREEMENT

- The parties approve the implementation of the Skills Training for the OSYs under the College of Technology, Main Campus, EVSU, Tacloban City.
- 2. The parties shall consult each other as regard to the total implementation of the Skills Training for the OSYs.
- The parties shall help each other source out resources and/or material for implementation of the Skills Training for the OSYs.

#### II. PURPOSE

To establish partnership arrangements that promote self/social development of the OSYs and implement convergent strategy while program is addressed towards skills development and building new opportunities for their families in a better way.

#### III. AREAS OF COOPERATION

The above goals will be accomplished by undertaking the following activities:

# A. LOCAL GOVERNMENT UNIT-BABATNGON, LEYTE shall:

- Identify project beneficiaries in coordination with the Municipal Social Welfare and Development Office;
- Submit list of project beneficiaries to EVSU as basis for attendance checklist and performance evaluation test;
- 3. Provide logistic support for the implementation of the project; including Trainor's Honorarium;
- 4. Provide/Procure training materials for the training program;
- 5. Disburse project funds as stated in the project proposal;
- 6. Facilitate implementation of the project;
- 7. Monitor project beneficiaries and strictly ensure regular attendance throughout the training course.

#### B. EASTERN VISAYAS STATE UNIVERSITY shall:

- Designate Extension Service Representative who will coordinate with the partner agencies;
- Identify Faculty Member/ Trainers to conduct the actual Skills Training for the duration of the training per course with follow-up sessions if needed for consultation and advice;
- Through the Trainers, conduct the actual training and appropriate practical tests to gauge participants' comprehension and absorption of the lesson and issue the certificate of completion together with the LGU-Babatngon, Leyte;

 Provide a suitable classroom/demonstration room/venue which will accommodate twenty 20) participants;

Together with the LGU-Babatngon, Leyte, an impact assessment will be conducted a month after the training;

6. Spearhead and facilitate opening and culminating activities in coordination with LGU-Babatngon, Leyte.

# IV. PROGRAM TERMINATION/REPLICATION

The project will be regularly reviewed to determine areas for improvement;
The project implementation will be terminated after the conduct of the Skills Training
The training would start upon availability of the Trainers, venue, training materials
sometime in the month of2016;
That training component will start on2016 until2016 and liquidation must be completed within 30 days after project completion.

# V. SEPARABILITY CLAUSE

In case any provision hereof or any part thereof be declared void or unenforceable by competent authorities, the remaining provision unaffected by such declaration shall remain valid and binding among the parties, their successors and assigns.

#### VI. EFFECTIVITY OF THIS AGREEMENT

This MEMORANDUM OF UNDERSTANDING shall take effect upon signing by the parties and shall remain in full force and effect unless sooner terminated in writing for any reason at the instance of any amendment of the provisions of the herein parties.
