KNOW ALL MEN THESE PRESENTS:

This **MEMORANDUM OF AGREEMENT** made and entered into at Barangay Dacay, Municipality of Dulag, Province of Leyte, Philippines on September 13, 2017 by and between:

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DOMINADOR O. AGUIRRE, JR.**, hereinafter referred to as **EVSU**

and

The **DACAY BARANGAY COUNCIL** with principal office at Barangay Dacay, Dulag, Leyte represented by its Barangay Chairperson, **HONORABLE ROSARIO D. ALICANDO** hereinafter referred to as the **DEVELOPMENT PARTNER**.

WITNESSETH

WHEREAS, the **EVSU** is a technological institution, mandated to develop the potentialities of Region VIII;

WHEREAS, **EVSU** implements fieldwork program in its Graduate School to implement instruction, research and extension functions related to uplift SOCIO - ECONOMIC CONDITION of the **DEVELOPMENT PARTNER**;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate.

ARTICLE I

POINTS OF AGREEMENT

1. The parties approve the Implementation of the Field Work Program of the EVSU Graduate School at Barangay Dacay, Dulag, Leyte related to SOCIO - ECONOMIC SECTOR of the DEVELOPMENT PARTNER;
2. The parties shall coordinate with each other as regards to the total implementation of any fieldwork program;
3. The parties shall help each other source out resources and/or materials for programs and projects of the barangay.

ARTICLE II

RESPONSIBILITIES OF EVSU

1. The EVSU shall inform its development partner of the intention to implement Field Work Program in the area and shall closely coordinate with the latter of all arrangements to be made;
2. The EVSU shall provide the manpower resources and other necessary materials within the capabilities of the fieldworkers that will be involved in its programs in the implementation and projects;
3. The EVSU shall further inform in writing the other party regarding the progress of the program;
4. The EVSU shall provide the development partner the report results of the community assessment and the projects implemented.

ARTICLE III

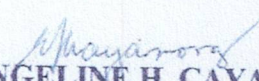
RESPONSIBILITIES OF THE DEVELOPMENT PARTNER

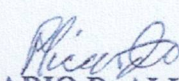
1. The DEVELOPMENT PARTNER shall assist, actively participate, facilitate the implementation and monitoring of the Field Work Program and Projects;
2. The DEVELOPMENT PARTNER shall take charge in providing the needed facilities necessary for the implementation of the project such as:
 - a. The frame for the community data board and be responsible for its installation.
 - b. Maintain and enhance the projects implemented by the fieldworkers.
3. The DEVELOPMENT PARTNER shall issue certification after completion of one hundred and eight (108) hours fieldwork rendered by the EVSU students;
4. The DEVELOPMENT PARTNER shall allow the use of necessary equipment available in its territorial jurisdiction in connection with the implementation of programs and projects.

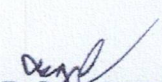
ARTICLE IV

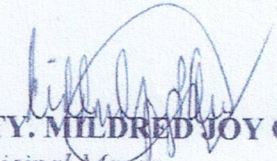
EFFECTIVITY

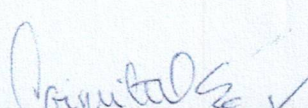

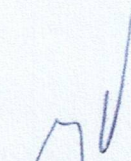

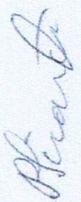
