KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at Tacloban City, Philippines on FEBRUARY 4, 2018 by and between;

The EASTERN VISAYAS STATE UNIVERSITY of Tacloban City represented by its President, DR. DOMINADOR O. AGUIRRE, JR., hereinafter as EVSU;

And

BOMBO RADYO TACLOBAN-PHILIPPINES represented by its Station Manager, MR. OGSIMER ACIDRE, hereinafter as BOMBO RADYO.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with four major functions, namely: instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement extension services programs to its immediate communities and identified clients together with its development partners;

WHEREAS, EVSU is mandated to implement an extension services program utilizing non-traditional and mainstream modalities in information dissemination to provide relevant information on various technologies that can help in income generation and employment opportunities to the people of Eastern Visayas;

WHEREAS, BOMBO RADYO is enjoined to develop linkage and networking with academic and other institutions to meet its goal of inclusive and wide spread coverage and reach of developmental information dissemination;

WHEREAS, BOMBO RADYO in its intention of providing livelihood and job opportunities to various sectors of the region engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

WHEREAS, BOMBO RADYO is committed in creating positive and progressive mindset among its listeners in Eastern Visayas that will effect to strategic decision making towards genuine community development;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES OF EVSU

- 1. EVSU shall provide available experts skilled technical manpower resources in the form of 1 or 2 CO-ANCHOR PERSONS and OTHER INVITED GUEST RESOURCE PERSONS for each Sunday episode of the new radio program entitled TECH TALK;
- 2. EVSU through the Office of the Extension Services will research on the identified topic and prepare the Storyline, Script and featured discussions for each episode. Topics may range on various technologies developed in the University and other appropriate technologies and relevant topics including environment, health, livelihood and entrepreneurship and etc.;
- 3. **EVSU** will provide the necessary ingredients, equipment (if needed), fliers, brochures and other information packages to be used in the radio program: **TECH TALK** to be made available to its program listeners and supporters;
- **4. EVSU** shall take the lead in the periodic monitoring and evaluation of the radio program **TECH TALK** for refinement, improvements and other technical components of the radio program.

B. RESPONSIBILITIES OF BOMBO RADYO

- BOMBO RADYO will coordinate with EVSU regarding the conduct of the live airing or taped episodes of the radio program and provide appropriate technical assistance
- 2. BOMBO RADYO will provide free air time to EVSU in airing various technology-based and other relevant topics every Sunday from 8:30-9:00 AM; part of its Corporate Social Responsibility initiatives; (but may change depending on the need and clamor of the listeners in the community).
- 3. **BOMBO RADYO** shall provide the necessary personnel: 1 Main Anchor, and/or 1 Co-Anchor, Radio Personnel 1 Electronics Communication Engineer and other relevant staff and personnel to ensure the smooth airing of each episode;
- 4. BOMBO RADYO being the Main Sponsor of this partnership will Provide free air time to EVSU in airing various technology-based topics every Sunday from 8:30-9:00 AM, under the GOOD MORNING PHILIPPINES - (Technology Segment) - Sunday Program part of its Corporate Social Responsibility initiatives;
 - C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:
- 1. It is expressly understood that there will be no employer-employee relationship between **BOMBO RADYO** and **EVSU** personnel extending assistance. No compensation shall be paid to the latter from the **BOMBO RADYO** and vice versa.

D. EFFECTIVITY

The Agreement shall be effective, valid and binding for 3 years from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
