The **Barangay Mahagnao of Burauen, Leyte** represented by its **Barangay Captain, HON. EULALIO P. AGUSTIN JR.**, herein after referred to as the **SECOND PARTY**.

WITNESSETH

WHEREAS, the **EVSU-Burauen Campus** is a higher learning institution mandated to develop the potentialities, of Region VIII;

WHEREAS, the **EVSU- Burauen Campus** is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, the **EVSU-Burauen Campus** implement extension service programs across departments, to wit: the Education Department, the Agriculture and Technology Department, including the Non-Teaching Staff and the NSTP-CWTS coordinator and students.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate.

ARTICLE I

POINTS OF AGREEMENT

1. The parties approved the implementation of the Extension Service Programs of the EVSU Burauen Campus particularly the Education Department, Agriculture and Technology Department and Business Entrepreneurship and Management Department, including the Non-Teaching Staff and the NSTP-CWTS Coordinator and students.
2. The parties shall consult each other as regard to the total implementation of any field work activities; and
3. The parties shall help each other sources out resources and/or material for program and project of the school and community.

ARTICLE II

RESPONSIBILITIES OF EVSU BURAUEN CAMPUS

1. The EVSU-Burauen Campus shall inform its development partners of its intention to implement Extension Service programs in the area and shall closely coordinate with latter of all arrangement to be made.
2. The EVSU-Burauen Campus shall provide the available skills and technical manpower resources that will be involved on its field work activities based on the needs of the community; and
3. The EVSU-Burauen Campus shall further inform in writing the other party regarding the progress of the program.

ARTICLE III

RESPOSIBILITIES OF THE TARGET COMMUNITY BENEFICIARIES

1. The Barangay shall assist/facilitate in the implementation monitoring of the Extension Services program.
2. The barangay shall assure the safety of EVSU-Burauen Campus personnel in the community;
3. The barangay shall take charge in providing the needed supply and/or materials for the field workers and issue certification of accomplishment after completion of certain activities; and
4. The Barangay shall allow the use of necessary equipment available in its territorial jurisdiction in connection with the implementations of the agreed programs and projects.

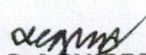
ARTICLE IV

EFFECTIVITY

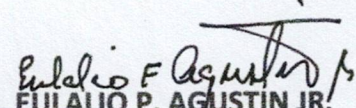

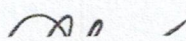
