**BARANGAY 43A**, duly recognized and existing under the Laws of the Republic of the Philippines, with Office address at Barangay 43A, Tacloban City, represented herein by **EVELYN B. MAGALONA** in her capacity as Barangay Chairman, referred to as "**BARANGAY 43A**".

**WITNESSETH:**

WHEREAS, the **Eastern Visayas State University (EVSU)**, in pursuit of the achievement of its mission and the Institutional Outcomes, needs to provide Extension Services to Municipalities or Barangays according to their needs for the improvement and development of its constituents.

WHEREAS, the **College of Engineering** with its quest to perform its core functions in Extension Community Services can provide professional and technical skills needed by the Barangay in the following fields of specialization:

- Industrial Engineering
- Civil Engineering
- Geodetic Engineering
- Electrical Engineering
- Electronics and Communication Engineering
- Mechanical Engineering
- Chemical Engineering
- Information Technology

WHEREAS, **BARANGAY 43A**, is committed to the improvement of the economic and social wellbeing of the country and its population;

NOW, THEREFORE, for and in consideration of the foregoing premises, **BARANGAY 43A**, hereby agrees to commit its full support and cooperation to **EVSU** in their desire to provide extension services to the barangay for the successful implementation of its programs and projects, under the terms and condition herein stipulated;

**A. DUTIES AND RESPONSIBILITIES**

**A.1. EASTERN VISAYAS STATE UNIVERSITY / COLLEGE OF ENGINEERING**

1. Shall coordinate closely with the Barangay of the needed requirements to implement the Extension Services Program to the identified area.
2. Provide technical and professional skills needed by the Barangay.
3. Conduct appropriate monitoring and evaluation of the programs and projects.
4. Inform the Barangay of any updates and development as a result of the monitoring and evaluation of the programs and projects.

**A.2. BARANGAY 43A**

1. Shall assists/facilitate in the implementation/monitoring and evaluation of the project.
2. Shall assure safety of all EVSU Extension personnel in the conduct of various related activities in the locality
3. Provide the needed supplies and/or materials to be used by the EVSU Extension personnel in the implementation of the programs and projects.
4. Issue a Certification of Accomplishment after completion of activities.
5. Allow the use of necessary equipment available in its territorial jurisdiction in connection with the implementation of the agreed programs and projects.
6. Encourage the full participants of the entire Barangay community in the various aspects of the programs and projects implementation.

**B. EFFECTIVITY**

The agreement shall be effective, valid and binding for three (3) years from the date of signing by the contracting parties without prejudice to the revision or modification of any or some of the provision which may hereinafter be agreed upon by the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this agreement for any justifiable reason upon fifteen (15) days of notice of intent.
