KNOW ALL MEN BY THESE PRESENT:

This MEMORANDUM OF AGREEMENT made and entered into Barangay 100 San Roque, Tacloban City, Philippines this Dec. 10, 2019 by and between

The COLLEGE of ARTS and SCIENCES of the EASTERN VISAYAS STATE UNIVERSITY (EVSU-CAS) of Tacloban City represented by its Dean, DR. FATIMA SOCORRO M. QUIANZON

and

The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City, represented by its Barangay Chairman, HONORABLE JELITO DELA CRUZ, herein referred to as the PARTNER BARANGAY.

WITNESSETH: That

WHEREAS, the Eastern Visayas State University is a higher learning institution mandated to develop the potentialities of Region VIII along four functions of institution, research, production and extension services,

WHEREAS, the EVSU implements an Extension Services Program across colleges and campuses and in this particular, the College of Arts and Sciences of the Main Campus, Tacloban City.

NOW, WHEREFORE, for and inconsideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I

POINTS OF AGREEMENT

1. The parties approve the implementation of the Extension Services Program of the College of Arts and Sciences of EVSU Main Campus (EVSU-CAS) at Barangay San Roque, Tacloban City.
2. The parties shall consult each other and plan as regard to the total implementation of any fieldwork activities to the project.
3. The parties shall help each other source out resources and/or materials for the programs and projects of the specified are of coverage.

ARTICLE II

RESPONSIBILITIES OF EVSU-CAS

1. The EVSU-CAS shall inform its partner barangay of its intention to implement Extension Services Program in the area and shall closely coordinate with the development of all arrangement to be made.
2. The EVSU-CAS shall provide the available skills and technical manpower resources that will be involved in its fieldwork activities based on the needs of the development partner and related to the project.
3. The EVSU-CAS shall help implement the socio-economic development programs, specifically along the following areas:
 - a. Community Continuing Education
 - b. Enterprise/Industry Development
 - c. Language Literacy
 - d. Capability Building
 - e. Gender and Development Program
 - f. Industry Association Development Program
 - g. Local Governance and Leadership
 - h. Environmental Management Program

4. The EVSU-CAS shall further inform in writing the other party regarding the progress of the program.

ARTICLE III

RESPONSIBILITIES OF THE BARANGAY COUNCIL OF SAN ROQUE

1. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall inform its constituents of the presence and assistance of EVSU-CAS and shall inform of their respective responsibilities in the development work.
2. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall ensure the safety of EVSU-CAS personnel in the locality.
3. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City and EVSU- CAS shall equally take charge of the expenses for the implementation of the livelihood program.
4. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall assist/facilitate in the implementation/monitoring of the Extension Services Program provided by EVSU-CAS.
5. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall provide coordination facility with other technical and fiscal support and by allowing the use of necessary equipment available in its territorial jurisdiction in connection with the implementation of the agreed programs or projects.
6. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall assist in the mobilization of technical and financial support coming from GO's and NGO's.
7. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall issue certification of the accomplishment after completion of certain activities.
8. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall provide EVSU-CAS with a working space preferably with a cottage for all EVSU-CAS personnel involved in the development work.
9. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City shall give discount to all EVSU-CAS personnel and students for the use of any of its facilities.
10. The BARANGAY COUNCIL OF SAN ROQUE, Tacloban City as the partner barangay shall facilitate in the implementation of small infrastructure related to the project.

ARTICLE IV

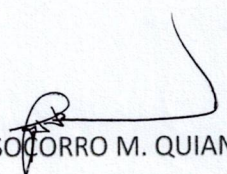
EFFECTIVITY

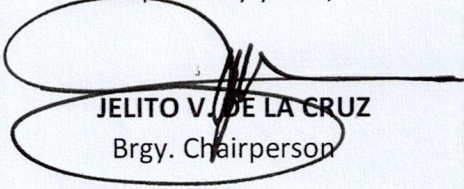
Greetings of peace!
