TRI-PARTY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This TRI-PARTY AGREEMENT made and entered into on January 28, 2019 at Tacloban City, Philippines by and among The EASTERN VISAYAS STATE UNIVERSITY of Tacloban City represented by its President, DR. DOMINADOR O. AGUIRRE, JR., herein referred to as **EVSU**, The FEDERATION OF SENIOR CITIZENS ASSOCIATION OF REGION VIII herein referred as **FESCARE** represented by its President Mrs. TERESA MONTUBIG, and COALITION OF SERVICES OF THE ELDERLY an Nongovernment organization for the older people represented by its Community Development Officer, ANIEWAY ALEGRADO herein referred to as **COSE**.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;
WHEREAS, EVSU is mandated with four major functions, the instruction, research, production, and

whereas, EVSU is mandated with four major functions, the instruction, research, production,/and extension services;

WHEREAS, EVSU is mandated to implement an extension services program utilizing non-traditional and main stream modalities in information dissemination to provide relevant information on various technologies that can help income generation and employment opportunities to the people of Eastern Visayas;

WHEREAS, FESCARE is enjoined to develop linkage and networking with academic and other institution to meet its goal to organize and empower the older people reach their satisfying and dignified life;

WHEREAS, COSE envisions to strengthen the Older People's Organization towards responsive and ageiendly cities and municipalities in Leyte.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES OF EVSU:

- EVSU shall extend technical assistance to older people's organizations in values formation, capacity building, and livelihood trainings;
- 2. It shall formulate and implement relevant and effective course designs and educational programs;
- It shall ensure the availability of the needed-educational facilities in the form of modular programs and other distance and alternative learning materials.
- 4. It shall ensure inclusion of its satellite campuses to conduct any related activities for the elderly particularly in Ormoc City, Tanauan, Carigara, Burauen and Dulag.
- 5. It shall conduct continuing research activities to be used as baseline information needed for further program development for the elderly.

B. RESPONSIBILITIES OF FESCARE:

- 1. It shall identify target participants and beneficiaries.
- 2. It shall conduct assessment and profiling activities.
- 3. It shall establish fundraising activities with the local and regional initiatives for the sustainability of programs and services of elderly.
- 4. It shall coordinate with the older people's association in conducting regular inter- municipality/city meetings or annual OPO summit to provide opportunity for the federations to share their emerging good practices in their respective areas.
- 5. It shall coordinate with relevant partners to ensure older people's access to formal and non-formal education.

C. RESPONSIBILITIES OF COSE

- 1. It shall assist partner agencies in conducting monitoring and evaluation activities.
- 2. It shall collaborate with FESCARE in local and national advocacy programs.

EFFECTIVITY

The Agreement shall be effective, valid and binding for 3 years (duration) from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may herein after be agreed upon by the contracting parties, PROVIDED that such provision or modification is consistent with the original intent and purpose of the Agreement. Nothing can prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) of notice.
