KNOW ALL MEN BY THESE PRESENTS:

This memorandum of agreement made this 09 day of DECEMBER 2019, Tanauan, Leyte by and between:

The MUNICIPAL OF TANAUAN, Leyte, represented by Mayor HON. PELAGIO R. TECSON, referred to as Local Government Unit.

The Eastern Visayas State University (EVSU), a government-owned educational institution created by virtue of Republic Act 9311, Tacloban City hereinafter referred to as the University represented by the President, Dr. Dominador O. Aguirre, Jr.

WITNESSETH

WHEREAS, the Eastern Visayas State University has an institutionalized Extension Service as a mandated Function, further emphasized under the Higher Education Act of 2012, to conduct Community Outreach and Community Development Program and Projects to deserving communities in the region;

WHEREAS, the Eastern Visayas State University through the College of Arts and Sciences and the Social Science and Economics Department will coordinate with the Department of Sciences and Technology Office 8 to extend technology assistance for the improvement of the production and livelihood in the barangay;

WHEREAS, the Eastern Visayas State University through the College of Arts and Sciences and the Social Science and Economics Department will extend assistance to Cogon Small Farmers Association and other Association based on assessed need for sustainability;

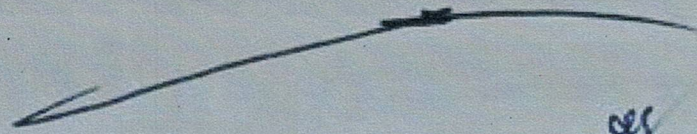
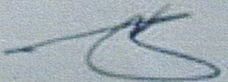
WHEREAS, the Eastern Visayas State University through the College of Arts and Sciences and the Social Science and Economics has considered Cogon Small Farmers Association with the prerequisite endowment necessary to propel leadership in the community by providing livelihood in the community;

WHEREAS, the Eastern Visayas State University through the College of Arts and Sciences and the Social Science and Economics can extend the same services to other existing associations in Tanauan, Leyte;

WHEREAS, the local government of Tanauan through the office of the Mayor have expressed to cooperate and collaborate towards building association's capability to address poverty alleviation program of the local government;

WHEREAS, the local government of Tanauan have various associations established after the onslaught of the typhoon Yolanda and became displaced in their livelihood;

NOW, THEREFORE, For and in consideration of the foregoing premises and their mutual covenant, the parties hereby agree to the following terms and conditions:

1. The Program

The following programs will be extended to Cogon Small Farmers Association and to other barangays in Tanauan:

- a. Values promotion and enrichment
- b. Livelihood enhancement
- c. Leadership and management training
- d. Consultancy
- e. Education and citizenship
- f. Cultural heritage conservation
- g. Community organizing

2. Responsibilities of the Parties

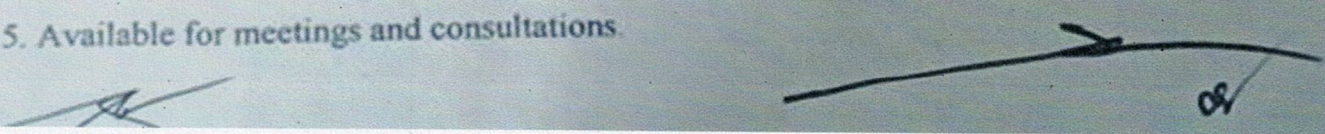
EVSU- Econ Department

- a. Provide a team to facilitate the implementation of the program;
- b. Undertake the documentation, monitoring and evaluation of the project implementation;
- c. Collaborate with other allied government agencies to strengthen extension activities in Tanauan;
- d. Propose relevant and significant mechanism to Mayor's Office vis-à-vis sustainability of community associations; and
- e. Update the Office of the Mayor of the development of extension activity in Tanauan.

Tanauan Association

1. Cooperate with the programs designed to strengthen association's leadership in the community;
2. Extend necessary help to the EVSU-Social Sciences and Economics Department during the period of contract; and
3. Provide relevant input of information as required by EVSU-Social Sciences and Economics Department.

Local Government of TANAUAN

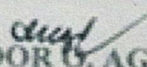
1. Identify from among the associations accredited by the local government to be considered for extension service of the College of Arts and Sciences.
 2. Provide a focal person in the implementation of the extension program of the EVSU-Economics Department;
 3. Extend necessary assistance such as logistic support to EVSU- Economics Department and barangay involved when needed; and
 4. Provide available materials in the Municipality necessary in the community;
 5. Available for meetings and consultations.

TERM OF AGREEMENT

This Memorandum of Agreement shall take effect on November 2019 and shall be terminated on November 2021. This MOA may be renewed every two (2) years upon agreement and decision of both parties such terms and conditions as may be agreed upon by them, unless sooner revoked by either party.

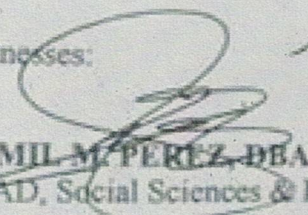
