

MEMORANDUM OF AGREEMENT

Manpower Development Training Implementation

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement, hereinafter referred to as the MOA, is made and entered into this 26th day of June, 2019, by and between;

The **Regional Rehabilitation Center for the Youth (RRCY)**, under the Department of Social Welfare and Development (DSWD), Field Office 8, Tacloban City, with office address at National Highway, Sto. Niño, Tanauan, Leyte, herein represented by **YVONNE SERRANO-ABONALES**, DSWD OIC - Regional Director, Region 8, herein referred to as RRCY;

and

The **Eastern Visayas State University (EVSU)**, an educational institution with principal address at Tacloban City, hereinafter represented by **DOMINADOR O. AGUIRRE, JR., DM**, President, hereinafter referred to as EVSU.

WITNESSETH THAT

WHEREAS, RRCY as a residential center for Children in Conflict with the Law (CICLs), aims to deliver comprehensive intervention for behavioral modification, including vocational skills promotive of self- help and renewed sense of human dignity;

WHEREAS, the same RRCY is mandated to deliver to its resident youths special non-formal skills training enabling each of them to be equipped with livelihood skills helpful once they are integrated to their families and communities;

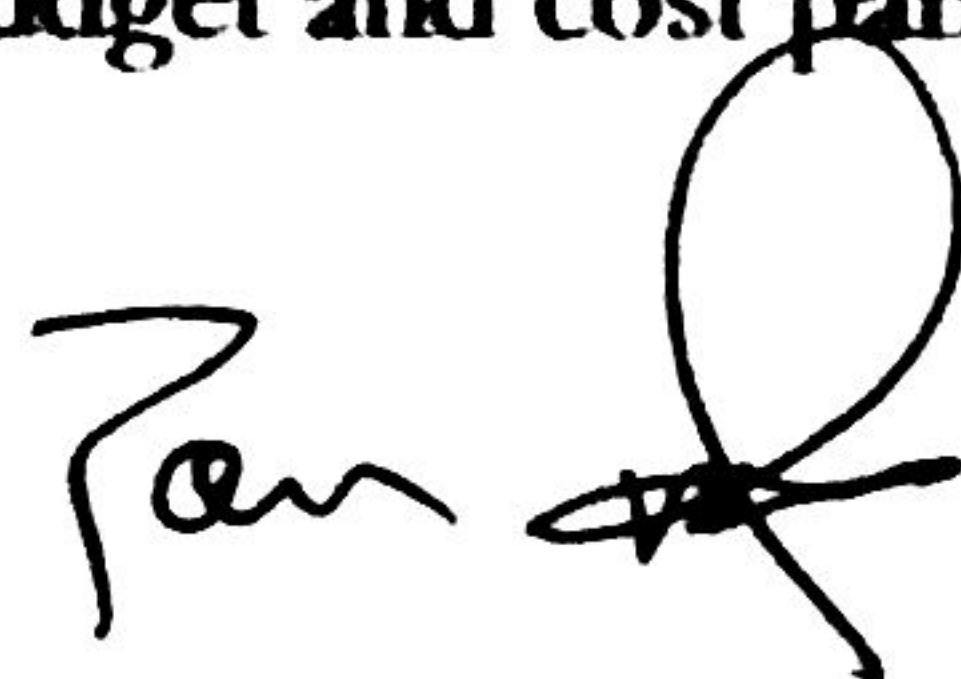
WHEREAS, the Eastern Visayas State University (EVSU) aims to develop, and has the capacity to deliver high-quality extension programs, technical assistance and other relevant human development interventions to rehabilitation centers in preparing Children in Conflict with the Law become useful upon return to their respective families and communities;

NOW, THEREFORE, for and in consideration of the foregoing premises, all parties mutually agree as follows:

I. AGREEMENTS

A. The Regional Rehabilitation Center for the Youth (RRCY),

1. Coordinate with EVSU through its Manpower Development Officer II, Mr. Dennis M. Ravas pertinent projects and activities helpful to the residents of RRCY, including its preparations, schedules and number of residents slated for particular short-term trainings – whether done within or outside of RRCY premises;
2. Cover transportation costs of trainers and service providers from EVSU – Main or its satellite campus to RRCY and back, in coordination within the available transport budget and cost parameter of DSWD Regional Office 8;



3. Monitor center-based livelihood trainings for residents of RRCY, through the House Parents, the RRCY Manpower Development Officer and other rehabilitation team members in coordination with Security Officers and Social Workers/Case Managers of RRCY to attain desired behavior modification; and
4. Coordinate with the Regional Program Coordinator of DSWD's Sustainable Livelihood Program (SLP), regarding the possible inclusion of residents to avail of the Program in sustaining such skills training activities.

B. The Eastern Visayas State University (EVSU),

1. Provide technical assistance in planning out and implementation of series of hard and soft manpower skills for implementation at RRCY – Tanauan, or in other pre-arranged venues for RRCY residents;
2. Provide development, assessment and evaluation of hard and soft manpower skills necessary for RRCY residents for their behavior modification in preparation for their re-integration to their respective families and communities;
3. Provide capability – building activities for RRCY residents through formal or non-formal trainings or coaching in manpower development activities;
4. Conduct monitoring and assessment on the progress of given manpower trainings, and recommend various strategies able to sustain, enhance and expand the quality training services provided, backed up by sustainability measures and marketing reach of the results and outcomes of the project implementation.

II. AMENDMENTS

de This Memorandum of Agreement may be amended in part or in full through a written proposal by either party, subject to negotiations and mutual agreement by the parties. This agreement may be rescinded or terminated upon written notice by any party.

This agreement shall take effect upon signing by all parties concerned.
