KNOW ALL MEN BY THESE PRESENTS:

This **MEMORANDUM OF AGREEMENT** made and entered into at Barangay Guindapunan East, Carigara, Leyte, Philippines on December 18, 2020 by and between:

The **EASTERN VISAYAS STATE UNIVERSITY- CARIGARA CAMPUS, (EVSU-CC)** a government agency duly created under the laws of the Republic of the Philippines, with office address at Brgy. Barugohay Norte, Carigara, Leyte, herein represented by its Campus Director, **DR. HERMINIGILDO S. BADION**, hereinafter referred to as **EVSU-CARIGARA CAMPUS**;

and

The **GUINDAPUNAN EAST BARANGAY COUNCIL** with principal office at Barangay Guindapunan, East ; Carigara, Leyte, herein represented by its Barangay Chairman, **HON. WENDELL J. AGUNOS**, hereinafter referred to as **DEVELOPMENT PARTNER**.

and

The **MUNICIPAL GOVERNMENT OF CARIGARA, LEYTE**, a government agency duly created under the laws of the Republic of the Philippines, herein represented by its Municipal Mayor **HON. EDUARDO C. ONG**, herein referred to as the **LOCAL GOVERNMENT UNIT**.

### WITNESSETH:

WHEREAS, the EVSU-CC is a higher learning institution mandated to develop the potentialities of Region VIII.

WHEREAS, the EVSU-CC is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, the EVSU-CC implement an extension services program across colleges and in this particular the CAMPUS/ COLLEGE of:

WHEREAS, the EVSU-CC Extension Program includes Gender and Development (GAD) and Extension Research Programs which the former involves Awareness and Advocacy and the latter covers the conduct of Research Work/ Activities for dissemination and or improvement of Extension Services delivery.

NOW, THEREFORE, for an inconsideration of the foregoing premises, the parties hereby agree and stipulate:

#### ARTICLE I POINTS OF AGREEMENT

1. The parties approved the implementation of the Extension Services Program of the EVSU-CC at Barangay Guindapunan East, Carigara, Leyte;
2. The parties shall consult each other as regard to the total implementation of any field work activities.
3. The parties approved the implementation of GAD Awareness and Advocacy of the EVSU-CC; and
4. The parties shall help each other source out resources and/or materials for programs and projects of the barangay.

#### ARTICLE II RESPNSIBILITIES OF EVSU-CC

1. The EVSU-CC shall inform its development partners of its intention to implement Research, Development and Extension Services (RDE) and GAD Awareness and Advocacy programs in the area and shall closely coordinate with the latter of all arrangement to be made.
2. The EVSU-CC shall provide the available skills and technical manpower resources that will be involved in its field work activities based on the needs of community.
3. The EVSU-CC shall further in writing the other party regarding the progress of the programs.

#### ARTICLE III RESPONSIBILITIES OF THE TARGET COMMUNITY/ BENEFICIARY

1. The Stakcholders/ Beneficiaries/ Barangay Officials of Brgy. Guindapunan East of Carigara, Leyte shall assist/ facilitate in the implementation/ monitoring of the RDE Services and GAD Awareness and Advocacy Programs;
2. The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Guindapunan East of Carigara, Leyte shall assure the safety of safety of EVSU-CC personnel and students in the locality;
3. The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Guindapunan East of Carigara, Leyte shall take charge in providing the needed supplies/ materials if available for the RDE Workers and issues certification after completion of programs and projects.
4. The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Guindapunan East of Carigara, Leyte shall allow the use of necessary equipment available in its territorial in connection with the implementation territorial jurisdiction in connection with the implementation of the agreed programs or projects.

**ARTICLE IV  
RESPONSIBILITIES OF THE MUNICIPAL GOVERNMENT OF  
CARIGARA, LEYTE**

1. The MUNICIPAL GOVERNMENT OF CARIGARA, LEYTE shall assist in the mobilization of technical or any support needed by the community that will help improve the economic conditions of the people in the community;
2. The MUNICIPAL GOVERNMENT OF CARIGARA, LEYTE shall coordinate in the implementation of the RDE activities and GAD Awareness and Advocacy;
3. The MUNICIPAL GOVERNMENT of CARIGARA, LEYTE shall look for the safety of the EVSU-CC faculty, staff, students and stakeholders.

**ARTICLE V  
EFFECTIVITY**

The agreement shall be effective, valid and binding for three (3) years from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provision which may hereinafter be agreed upon the contracting parties that such revision or modification are consistent with the original intent and purpose of this agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice of intent.

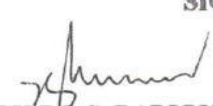
