The EASTERN VISAYAS STATE UNIVERSITY of Tacloban City represented by its OIC-President, DR. GEORGE M. COLORADO, hereinafter as EVSU.

And

The Barangay Lake Danao, Ormoc City represented by its Barangay Chairman, HON. RICHARD P. IMPAS, hereinafter to as LGU.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with for major functions, the instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement as extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, the **LGU** is enjoined to develop linkage and networking with academic and other institutions to meet its goal of income generation for its constituents;

WHEREAS, the LGU in its intention of providing livelihood and job opportunities to various sectors of the City engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES

 The EVSU shall provide available skills and technical manpower resources to the LGU whenever required by the latter's livelihood and entrepreneurship program and projects (House Electrical Wiring, House Planning, Plumbing, Welding, Computer Literacy, Health and Personal Hygiene, Disaster Risk Reduction Management Training, Food Safety and Sanitation/Food Handling, Workshop/Training in Bookkeeping, Cooking/Baking, Mathematics Tutorial, Knowledge and Skills about

Livelihood, Opportunities and Values Education, Environmental Awareness, Good Works and Plans about Plastic Wastes/Eco bricks, Health Nutrition and Sanitation, Food Processing and Beauty Care/Massage);

- Inform LGU of any supplies or material required by its personnel in the conduct of skills and technical assistance; and
- The EVSU shall inform the LGU of possible and potential program of the University related to livelihood and entrepreneurship.

B. RESPONSIBILITIES OF BRGY. LAKE DANAO, ORMOC CITY

- Inform and coordinate with EVSU the conduct of livelihood and entrepreneurship programs and projects that will require necessary technical assistance from EVSU;
- The LGU shall ensure the availability of supplies and/ or materials to be used by that the EVSU personnel when extending skills and technical assistance to LGU activities; and
- The LGU shall ensure the security of the skills and technical manpower resources sent by EVSU to any of the program and projects implemented by the LGU.

C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

- It is expressly understood that there will be no employer-employee relationship between the LGU and EVSU personnel extending assistance. No compensation shall be paid to the latter from LGU.
- EVSU shall defend, indemnify and hold the LGU its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, error or omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of the LGU.

D. EFFECTIVITY

The Agreement shall be effective, valid and binding for **three (3) years** from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent for any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
