

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at **CAMP BRYZTOFF** in Brgy. Rizal, Dulag, Leyte, Philippines on October 21, 2021 by and between;

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DENNIS C. DE PAZ.**, hereinafter as **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**;

And

CAMP BRYZTOFF, represented by its Operations Manager, **LOURLEEN BRILLO**, hereinafter to as **CAMP BRYZTOFF**;

WITNESSETH:

WHEREAS, EASTERN VISAYAS STATE UNIVERSITY (EVSU), is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, the EASTERN VISAYAS STATE UNIVERSITY (EVSU), in fulfillment to its mandate to help empower communities by providing the needed technological and profound expertise of the university through the Extension Services Programs, and its effort to help contribute in the rehabilitation and rebuilding programs of its development partners and identified clients;

WHEREAS, CAMP BRYZTOFF is enjoined to develop linkage and networking with academic and other institutions to meet its goal of developing competitive manpower for its establishment;

WHEREAS, CAMP BRYZTOFF in its intention of providing livelihood and job opportunities to its locality to engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I

POINTS OF AGREEMENT

1. The parties approve the implementation of a relevant and comprehensive capability building program which includes, but not limited to, i.e., skills and other technology transfer training for the management, staff and crew of **CAMP BRYZTOFF** of Brgy. Rizal, Dulag, Leyte under the tutelage of the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**, Tacloban City.
2. The parties shall consult each other as regards the overall implementation of the comprehensive capability building program for all the identified stakeholders of **CAMP BRYZTOFF**, Brgy. Rizal, Dulag, Leyte.
3. The parties shall help each other find appropriate resources and/or materials for the implementation of the Comprehensive Capability Building Program.

ARTICLE II

PURPOSE

To establish partnership arrangements that will help develop individually and collectively all the stakeholders of Camp Bryztoff including its host community through convergent strategy.

ARTICLE III

AREAS OF COOPERATION

A. CAMP BRYZTOFF shall:

1. Identify project beneficiaries.
2. Submit list of project beneficiaries to **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** as basis for attendance checklist and performance evaluation test;
3. Provide logistical support for the implementation of the project.
4. Provide food and accommodation for the trainers.
5. Provide/Procure training materials for the training programs;
6. Facilitate implementation of the project;
7. Monitor project beneficiaries and strictly ensure regular attendance throughout the training course.
8. Provide a suitable training/demonstration room/venue which will accommodate at least twenty (20) participants to include the representatives/trainors/faculty members of the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**.

B. EASTERN VISAYAS STATE UNIVERSITY (EVSU) shall:

1. Provide available skills and technical manpower resources to the **CAMP BRYZTOFF** whenever required by the latter's entrepreneurship program and projects to be spearheaded by the College of Technology with the assistance of other Colleges in the University when needed.

ARTICLE IV

ROLES OF TRAINEES

1. Trainees shall be committed to attend/participate the training process within the duration of training.
2. Trainees shall accept and perform tasks and other related assignments related to the training.
3. Trainees shall complete tasks, assessments, assignments, etc. that are set by the Trainer/s.

ARTICLE V

UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

1. It is expressly understood that there will be no employer-employee relationship between **CAMP BRYZTOFF** and **EVSU** personnel extending assistance.
2. **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** shall defend, indemnify and hold **CAMP BRYZTOFF** and its management, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of **EVSU** personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of **CAMP BRYZTOFF**.

ARTICLE VI

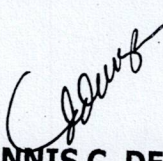
EFFECTIVITY CLAUSE

The Agreement shall be effective, valid and binding for **(3 years)** from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.

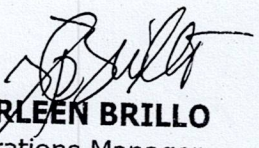
