

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at Pastrana Leyte, Philippines on DECEMBER 28, 2021 by and between

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DENNIS C. DE PAZ** hereinafter as **EVSU**

And

The **BRGY. CANCARAJA PASTRANA, LEYTE**, represented by its Barangay Chairman, **HON. JONELL B. DOMINICO**, hereinafter to as **BRGY. CANCARAJA**.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement an extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, CANCARAJA is enjoined to develop linkage and networking with academic and other institutions to meet its goal of income generation for its constituents;

WHEREAS, CANCARAJA in its intention of providing livelihood and job opportunities to various sectors of the Barangay engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES OF EVSU

1. The EVSU shall provide available skills and technical manpower resources to BRGY. CANCARAJA whenever required by the latter's livelihood and entrepreneurship program and projects;

2. Inform BRGY. CANCARAJA of any supplies or materials required by the personnel in the conduct of skills and technical assistance.
3. The EVSU shall inform BRGY. CANCARAJA of possible and potential program of the University related to livelihood and entrepreneurship;

**B. RESPONSIBILITIES OF THE BARANGAYA LOCAL GOVERNMENT
UNIT OF CANCARAJA**

1. Inform and coordinate with EVSU the conduct of livelihood and entrepreneurship programs and projects that will require necessary technical assistance from EVSU;
2. The BRGY. CANCARAJA shall ensure the availability and cooperation of personnel when extending skills and technical assistance to BLGU activities.
3. The BRGY. CANCARAJA shall ensure the security of the skills and technical manpower resources sent by EVSU to any of the program and projects implemented by the BLGU.

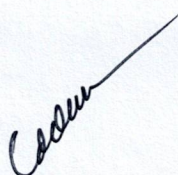
**C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND
CONDITIONS ARE LIKEWISE INCLUDED:**

1. It is expressly understood that there will be no employer-employee relationship between the BRGY. CANCARAJA and EVSU personnel extending assistance. No compensation shall be paid to the latter from the BLGU.
2. EVSU shall defend, indemnify and hold the BLGU its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of the BLGU.

D. EFFECTIVITY

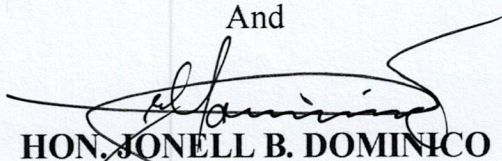
The Agreement shall be effective, valid and binding for **five (5) years** from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
