

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at Brgy. Daguitan, Dulag, Leyte, Philippines on November 06, 2021 by and between;

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DENNIS C. DE PAZ**., hereinafter as **EVSU**;

And

LGU-Brgy. Daguitan, Leyte, represented by its Brgy. Chairwoman, **HON. EDITA S. DE VEYRA**., hereinafter to as **LGU**;

WITNESSETH:

WHEREAS, EASTERN VISAYAS STATE UNIVERSITY (EVSU), is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, the EASTERN VISAYAS STATE UNIVERSITY (EVSU), in fulfilment to its mandate to help empower communities by providing the needed technological and profound expertise of the university through the Extension Services Programs, and its effort to help contribute in the rehabilitation and rebuilding programs of its development partners and identified clients;

WHEREAS, LGU is enjoined to develop linkage and networking with academic and other institutions to meet its goal of developing competitive manpower for its establishment;

WHEREAS, LGU in its intention of providing livelihood and job opportunities to its locality to engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I

POINTS OF AGREEMENT

1. The parties approve the implementation of the skills Training for the OSYs under College of Technology, Main Campus, EVSU, Tacloban City
2. The parties shall consult each other as regards the overall implementation of the skills Training for the OSY's and Unemployed Parents at Brgy. Daguitan, Dulag, Leyte.
3. The parties shall help each other find appropriate resources and/or materials for the implementation of the Comprehensive Capability Building Program.



ARTICLE III

AREAS OF COOPERATION

A. LGU-Brgy. Daguitan, Dulag, Leyte shall:

1. Identify project beneficiaries.
2. Submit list of project beneficiaries to **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** as basis for attendance checklist and performance evaluation test;
3. Provide logistical support for the implementation of the project.
4. Provide food and accommodation for the trainers.
5. Provide/Procure training materials for the training programs;
6. Facilitate implementation of the project;
7. Monitor project beneficiaries and strictly ensure regular attendance throughout the training course.

B. EASTERN VISAYAS STATE UNIVERSITY (EVSU) shall:

1. The EVSU through the College of Technology shall provide the technical expertise needed for this undertaking, such as, but not limited to the following:

- a. Bamboo Handicraft
- b. Basic Cooking
- c. Electrical and Building Wiring
- d. Basic Electronics
- e. Welding and Fabrication
- f. Bartending
- g. Computer Literacy
- h. Auto-Mechanics Repair and Driving
- i. Food Processing
- j. T-shirt Printing
- k. Table Setting and Skirting
- l. Dress making
- m. Carpentry, Masonry and Furniture Making

2. The EVSU, through its College of Technology, shall provide the manpower resources which will be included in its extension program/project;

3. The EVSU thru the College of Technology and Office of Research and Extension Services.

ARTICLE IV

ROLES OF TRAINEES

ARTICLE V

UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

1. It is expressly understood that there will be no employer-employee relationship between LGU and EVSU personnel extending assistance.
2. EVSU shall defend, indemnify and hold LGU its officers, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of LGU.

ARTICLE VI

EFFECTIVITY

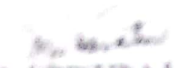
