MEMORANDUM OF AGREEMENT FORGING RESEARCH AND DEVELOPMENT, AND EXTENSION (RDE) PARTNERSHIP BETWEEN EASTERN VISAYAS STATE UNIVERSITY AND THE MUNICPALITY OF JARO, LEYTE

KNOW ALL MEN BY THESE PRESENT:

This MEMORANDUM OF AGREEMENT made and entered into at Jaro, Leyte, Philippines on December 28, 2021 by and between

The EASTERN VISAYAS STATE UNIVERSTY, with office address at Tacloban City, represented by its President, DR. DENNIS C. DEPAZ., hereinafter referred as EVSU and

The MUNICIPALITY OF JARO, LEYTE, a local government unit existing under Philippine Laws with office address at Jaro, Leyte, represented by the Mayor, HON. RODRIGO C. ARBAS, hereinafter referred as LGU Jaro

WITNESSETH:

WHEREAS, as a state university EVSU is mandated to undertake research and development initiatives, projects and extension services and provide progressive leadership in its areas of specialization;

WHEREAS, in the fulfillment of its function, EVSU is further mandated to develop and establish consortia and other economic forms of linkages with local government units to promote inclusive growth and sustainable development;

WHEREAS, sec. 16 of R.A. 7160 otherwise known as the "Local Government Code of 1991", LGU Jaro is mandated to exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, in the fulfillment of its mandate LGU Jaro needs technical guidance and knowledge-driven initiatives along research and development, and extension services from EVSU to effectively pursue its programs and projects.

NOW, THEREFORE, for and in consideration of the above premises and mutual covenants, agreements and stipulations hereinafter set forth, the parties hereby agree on the following stipulations:

ARTICLE I SCOPE AND PURPOSE

The Purpose of this MOA is to provide a framework of cooperation and partnership within which EVSU through its Graduate School and the LGU Jaro, Leyte shall work and collaborate on programs and projects. This MOA shall generally govern research and development, and extension services rendered by EVSU to LGU Jaro ys Delosk in pursuance of the latter's programs and projects.



ARTICLE II RESPONSIBILITIES OF EVSU

The **EVSU** through its Graduate School and the other Colleges at the Main Campus shall provide research and development, and extension services in pursuance of LGU Jaro's programs and projects;

Specifically, **EVSU** shall extend technical and manpower assistance to LGU Jaro whenever required for any program and/or project of the latter;

The **EVSU** shall perform other acts necessary and incidental to providing research and development, and extension services to LGU Jaro.


ARTICLE III RESPONSIBILITIES OF LGU JARO

The **LGU Jaro** shall coordinate with EVSU all programs and projects that will require necessary technical and manpower assistance in furtherance of research and development and extension services to be provided.

The **LGU Jaro** shall ensure the availability of supplies and/or materials to be used by EVSU personnel in furtherance of research and development, and extension services to be provided.



The **LGU Jaro** shall ensure the security of the technical personnel provided by EVSU in furtherance research and development, and extension services to be conducted.





The **LGU Jaro** shall perform other acts necessary and incidental to research and development, and extension services to be provided.



This MOA shall be effective, valid and binding for one year from the date of the last signature.

The parties may extend or renew this MOA by agreement, confirmed in a written amendment signed by each party's authorized signatory.

No amendment of the terms of the MOA will be effective unless made in writing and signed by each party's authorized signatory.
