

MEMORANDUM OF AGREEMENT
KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at **PAYAG NI LOLO IRI** in Tanauan, Leyte Philippines on August 20, 2021 by and between

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DENNIS C. DE PAZ.**, hereinafter as **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**.

And

The **PAYAG NI LOLO IRI**, represented by its General Manager, **RYAN PAUL UDTOHAN.**, hereinafter to as **PAYAG NI LOLO IRI**.

WITNESSETH:

WHEREAS, EASTERN VISAYAS STATE UNIVERSITY (EVSU), is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, the EASTERN VISAYAS STATE UNIVERSITY (EVSU), in fulfillment to its mandate to help empower communities by providing the needed technological and profound expertise of the university through the Extension Services Programs, and its effort to help contribute in the rehabilitation and rebuilding programs to its development partners and identified clients;

WHEREAS, the PAYAG NI LOLO IRI is enjoined to develop linkage and networking with academic and other institutions to meet its goal of developing competitive manpower for its establishment;

WHEREAS, the PAYAG NI LOLO IRI in its intention of providing livelihood and job opportunities to its locality to engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I

POINTS OF AGREEMENT

1. The parties approve the implementation of a relevant and comprehensive capability building program which includes, but not limited to, i.e., Skills and other technology transfer training for the staff and members of the **PAYAG NI LOLO IRI** of Brgy. Sacme, Tanauan, Leyte under the tutelage of the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**, Tacloban City.
2. The parties shall consult each other as regard the overall implementation of the comprehensive capability building program for the staff and members of the Farm Retreat Villa of **PAYAG NI LOLO IRI**, Tanauan, Leyte
3. The parties shall help each other find appropriate resources and/or materials for the implementation of the Comprehensive Capability Building Program.

ARTICLE II

PURPOSE

To establish partnership arrangements that will help develop individually and collectively all the members of the Farm Retreat Villa as well as its host community through convergent strategy

ARTICLE III

AREAS OF COOPERATION

A. PAYAG NI LOLO IRI shall:

1. Identify project beneficiaries in coordination with the **PAYAG NI LOLO IRI** Administration.
2. Submit list of project beneficiaries to **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** as basis for attendance checklist and performance evaluation test;
3. Provide logistical support for the implementation of the project.
4. Provide/Procure training materials for the training programs;
5. Facilitate implementation of the project;
6. Monitor project beneficiaries and strictly ensure regular attendance throughout the training course.
7. Provide a suitable Training/demonstration room/venue which will accommodate twenty (20) participants; Together with the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** Faculty.

B. EASTERN VISAYAS STATE UNIVERSITY (EVSU) shall:

1. Provide available skills and technical manpower resources to the **PAYAG NI LOLO IRI** whenever required by the latter's livelihood and entrepreneurship program and projects.

3. Trainees shall complete tasks, assessments, assignments, etc. that are set by the Trainer/s.

ARTICLE V

UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

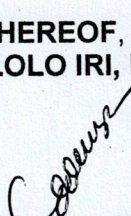
1. It is expressly understood that there will be no employer-employee relationship between the **PAYAG NI LOLO IRI** and **EVSU** personnel extending assistance.
2. **EASTERN VISAYAS STATE UNIVERSITY (EVSU)** shall defend, indemnify and hold the **PAYAG NI LOLO IRI** and its management, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of **EVSU** personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of the **PAYAG NI LOLO IRI**.

ARTICLE VI

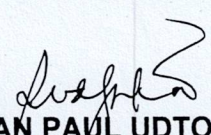
EFFECTIVITY CLAUSE

Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.

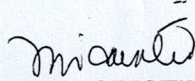
