

**MEMORANDUM OF UNDERSTANDING

Preamble

The **EASTERN VISAYAS STATE UNIVERSITY** and the **CANCARAJA ELEMENTARY SCHOOL** enter into this Memorandum of Understanding (MOU) for the purpose of implementing the **MAESTRAH Program** serving students from Cancaraja Elementary School.

Objectives

The purpose of this Memorandum of Understanding is to initiate collaboration among the faculty members from Eastern Visayas State University, College of Education and the teachers from Cancaraja Elementary School thru:

- ✓ Sharing of knowledge and best practices in pedagogy;
- ✓ Assisting children in developing the basic academic skills necessary to succeed in school;
- ✓ Engaging children in diverse enrichment activities to encourage the development of well-rounded individuals;
- ✓ Providing children and their families with literacy skills necessary to build successful futures.

The **CANCARAJA ELEMENTARY SCHOOL** is committed to realizing the goals of the **MAESTRAH Program**. In furtherance of this effort, this MOU establishes the framework for a formal working relationship between the parties to this agreement and specifies the resources that each commits to the program.

EVSU-COED, acting as lead agent, will work with **CANCARAJA ELEMENTARY SCHOOL** partners to coordinate and ensure the overall success of the activities.

Scope of Collaboration

Collaborative activities covered in this MOU shall cover the following;

1. Share and exchange of valuable information, knowledge, experience, and latest developments in different areas of teaching.
2. Implement possible and potential program of the University related to teaching and pedagogies.
3. Initiate collaboration among teachers in Cancaraja Elementary School and Eastern

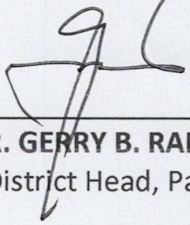
Visayas State University specifically College of Education to benefit the school children they dearly serve.

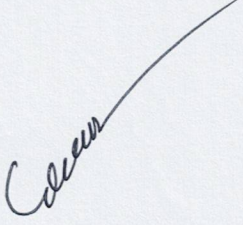
4. Actively participate in implementing activities and will have representation at all meetings or activities.

Other Terms and Conditions

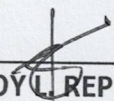
1. This Memorandum of Understanding is effective immediately upon its signing by the appropriate officer of each of the signatory institutions.
2. This Memorandum of Understanding shall remain effective for five (5) years from the date of last signature; and can be renewed, amended or modified by an exchange of letters between both parties.
3. Either party may terminate this Memorandum of Understanding by written notice to the other party; however, the Memorandum of Understanding will remain effective for 180 days from the date of issue of such notice.
4. Disputes or disagreements relating to this Memorandum of Understanding will be resolved by negotiations between the signatories of both parties.
5. Special conditions that are not covered by this general Memorandum of Understanding shall be covered by their own particular Memorandum of Understanding as supplement for this document.
