And

The **CAN-JOSE FARMERS ASSOCIATION**, represented by its Association President, **REBECCA G. SANGUENZA**, hereinafter to as **CFA**.

**WITNESSETH:**

**WHEREAS, EVSU** is a higher learning institution mandated to develop potentialities of Region VIII;

**WHEREAS, EVSU** is mandated with four major functions, the instruction, research, production and extension services;

**WHEREAS, EVSU** is mandated to implement an extension services program to its immediate communities and to its development partners and identified clients;

**WHEREAS, CAN-JOSE FARMERS ASSOCIATION** is enjoined to develop linkage and networking with academic and other institutions to meet its goal of income generation for its members;

**WHEREAS, CAN-JOSE FARMERS ASSOCIATION** in its intention of providing livelihood and job opportunities to its members to engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

**A. RESPONSIBILITIES OF EVSU**

1. The EVSU shall provide available skills and technical manpower resources to CAN-JOSE FARMERS ASSOCIATION whenever required by the latter's livelihood and entrepreneurship program and projects;
2. Inform CAN-JOSE FARMERS ASSOCIATION of any supplies or materials required by the personnel in the conduct of skills and technical assistance.
3. The EVSU shall inform CAN-JOSE FARMERS ASSOCIATION of the possible and potential program of the University related to livelihood and entrepreneurship;

**B. RESPONSIBILITIES OF THE CAN-JOSE FARMERS ASSOCIATION**

1. Inform and coordinate with EVSU on the conduct of livelihood and entrepreneurship programs and projects that will require necessary technical assistance from EVSU;
2. The CAN-JOSE FARMERS ASSOCIATION shall ensure the availability and cooperation of personnel when extending skills and technical assistance to CFA activities.
3. The CAN-JOSE FARMERS ASSOCIATION shall ensure the security of the skills and technical manpower resources sent by EVSU to any of the program and projects implemented by the BLGU.

**C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:**

1. It is expressly understood that there will be no employer-employee relationship between the CAN-JOSE FARMERS ASSOCIATION and EVSU personnel extending assistance. No compensation shall be paid to the latter from the association.
2. EVSU shall defend, indemnify and hold the CFA its officers members and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or



omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of the association.

**D. EFFECTIVITY**

The Agreement shall be effective, valid and binding for **five (5) years** from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.






