MEMORANDUM OF AGREEMENT

Between Department of Social Welfare and Development Field Office VIII and eastern Visayas State University for the College Education of Regional Rehabilitation Center for Youth (RRCY)

KNOW TO ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement, hereinafter referred to as the MOA, is made and entered into this 15th day of March, 2022, by and between;

The Department of Social Welfare and Development (DSWD) – Regional Rehabilitation Center for the Youth (RRCY), with office address at National Highway, Sto. Niño, Tanauan, Leyte, herein represented by GRACE Q. SUBONG, DSWD – Regional Director, herein referred to as RRCY;

and

The **Eastern Visayas State University (EVSU)**, a state university converted pursuant to Republic Act No. 9311, with office address at Salazar St., Quarry District, Tacloban City, hereinafter represented by **DENNIS C. DE PAZ, Ph.D.**, University President, hereinafter referred to as **EVSU**.

That both parties shall hereinafter be collectively referred to as PARTIES:

WITHNESSETH THAT:

WHEREAS, DSWD FO VIII - RRCY as a resident center **for Children in Conflict with the Law** (CICLs) which aims to provide opportunities to its residents for College Education to maximize the rehabilitation efforts of the Office, equip the youth with lifelong skills and empower them to be productive citizens of the country;

WHEREAS, the Eastern Visayas State University (EVSU) is mandated under R.A. 9311 to primarily provide advanced education, higher technological, professional instruction and training in trade, fishery, agriculture, forestry, science, education, commerce, architecture, engineering and related courses;

WHEREAS, the Eastern Visayas State University (EVSU), through its Tanauan Campus, aims to assist in developing the residents of RRCY, and has the capacity to deliver high-quality instruction, technical assistance and other relevant human development interventions to the rehabilitation center in preparing Children in Conflict with the Law become useful upon return to their respective families and communities;

NOW, THEREFORE, for and in consideration of the foregoing premises, all parties mutually agree as follows:

I. AGREEMENTS

A. The DSWD FO VIII:

 RRCY through its OIC Center Head, Mrs. Georgina M. Bulasa will coordinate with EVSU Tanauan Campus (EVSU-TC) pertinent to its projects and activities helpful to the residents of RRCY, including its preparations,

- schedules and number of residents slated for a particular college degree program whether done within or outside of RRCY premises;
- Cover costs of school and instructional materials needed as medium of instruction for service providers from EVSU.
- Monitor center-based classroom instructions for residents of RRCY, through the House Parents, the RRCY Social Workers and other rehabilitation team members in coordination with Security Officers of RRCY to attain desired behavior modifications; and
- Coordinate with the Center Head of RRCY regarding the possible inclusion of residents to avail of the Program in sustaining such course offering.

B. The Eastern Visayas State University (EVSU),

- Provide academic technical assistance to RRCY residents that includes online interview and enrollment, scheduling of classes, assigning of faculty, conducting synchronous and asynchronous classes and assist in the conduct of laboratory activities in the program Bachelor of Science in Industrial Technology, major in Electricity;
- Provide development, assessment and evaluation of class instructions of RRCY residents for their personal advancement in preparation for their reintegration to their respective families and communities;
- Conduct monitoring and assessment on the progress of given class instructions, and recommend various strategies able to sustain, enhance and expand the quality instruction services provided, backed up by sustainability measures and marketing reach of the results and outcomes of the project implementation.



II. AMENDMENTS

This Memorandum of Agreement may be amended in part or in full through a written proposal by either party, subject to negotiations and mutual agreement by the parties. This agreement may be rescinded or terminated upon written notice by any party.



III. EFFECTIVITY AND TERMINATION

This is agreement shall take effect upon signing by all parties concerned and subject to renewal upon agreement of both parties.
