The **EASTERN VISAYAS STATE UNIVERSITY** of Ormoc City represented by its President, **DR. DENNIS C. DE PAZ**, hereinafter as EVSU.

And

The Federation of Senior Citizens Association of Ormoc (FSCAO), represented by its FSCAO President, **MANUEL B. COMAGDANG**, hereinafter to as Senior Citizens Association of Ormoc.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement an extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, the FSCAO is enjoined to develop linkage and networking with academic and other institutions to meet its goal of income generation for its constituents;

WHEREAS, the FSCAO in its intention of providing livelihood and job opportunities to various sectors of the city engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES OF EVSU

The EVSU shall provide available skills and technical manpower resources to the FSCAO
whenever required by the latter's livelihood and entrepreneurship program and projects
(Cooking/Baking, Math and Computer Tutorial, DRRM Training, Public Speaking and Basic
English Training, Health and Wellness, Clean-up Drive Monitoring/Cleanliness), Basic
Accounting, Book Keeping and Livelihood.

- 2. Inform FSCAO of any supplies or materials required or materials required by its personnel in the conduct of skills and technical assistance:
- 3. The EVSU shall inform the FSCAO of possible and potential program of the University related to livelihood and entrepreneurship;

B. RESPONSIBILITIES OF FEDERATION OF SENIOR CITIZENS ASSOCIATION OF ORMOC

- Inform and coordinate with EVSU the conduct of livelihood and entrepreneurship programs and projects that will require necessary technical assistance from EVSU;
- 2. The FSCAO shall ensure the availability of supplies and/ or materials to be used by that the EVSU personnel when extending skills and technical assistance to FSCAO activities.
- 3. The FSCAO shall ensure the Utilization of the skills and technical manpower resources sent by EVSU to any of the program and projects implemented by the FSCAO.

C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

- It is expressly understood that there will be no employer-employee relationship between the FSCAO and EVSU personnel extending assistance. No compensation shall be paid to the latter from the FSCAO.
- EVSU shall defend, indemnify and hold the FSCAO its officers, officials, employees and
 volunteers harmless from any and all claims, injuries, damages, loss or suits including
 attorney fees, arising out of or resulting from the acts, errors or omissions of EVSU
 personnel in the performance of this agreement, except for injuries and damages caused
 by the sole negligence of the FSCAO.

D. EFFECTIVITY

The Agreement shall be effective, valid and binding for three (3) years from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
