#### MEMORANDUM OF AGREEMENT

## KNOW ALL MEN BY THESE PRESENT:

This MEMORANDUM OF AGREEMENT made and entered into with SHADOW ARTS THEATER ORGANIZATION (SATO) in EVSU, Tacloban City, Philippines on May 20, 2022 by and between

The EASTERN VISAYAS STATE UNIVERSITY (EVSU), as SUC created pursuant to RA No. 9311, through its COLLEGE OF ARTS AND SCIENCES (CAS) spearheaded by the DEPARTMENT OF CHEMISTRY (DChem) located at Quarry District, Tacloban City represented by its President, DR. DENNIS C. DE PAZ, herein referred as EVSU – DChem.

and

The SHADOW ARTS THEATER ORGANIZATION (SATO), represented by its Organization President, MR. ADRIAN ROCA FUMAR, hereinafter to as SHADOW ARTS THEATER ORGANIZATION (SATO).

## WITNESSETH:

WHEREAS, EASTERN VISAYAS STATE UNIVERSITY (EVSU), is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, the EASTERN VISAYAS STATE UNIVERSITY (EVSU), in fulfillment to its mandate to help empower communities by providing the needed technological and profound expertise of the university through the Extension Services Programs, and its effort to help contribute in the rehabilitation and rebuilding programs to its development partners and identified clients;

WHEREAS, the SHADOW ARTS THEATER ORGANIZATION (SATO) is enjoined to develop linkage and networking with academic and other institutions to meet its goal of developing competitive manpower for its organization;

WHEREAS, the SHADOW ARTS THEATER ORGANIZATION (SATO) in its intention of providing livelihood and job opportunities to its locality to engage in meaningful partnership with EVSU for technical skills assistance and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

### ARTICLE I

## POINTS OF AGREEMENT

1. The parties approve the implementation of a relevant and comprehensive capability building program which includes, but not limited to, i.e., Skills and other technology transfer training for the staff and members of the SHADOW ARTS THEATER ORGANIZATION (SATO) of Palo, Leyte under the tutelage of the DEPARTMENT OF CHEMISTRY of the COLLEGE OF ARTS AND SCIENCES - EASTERN VISAYAS STATE UNIVERSITY (EVSU), Tacloban City.

2. The parties shall consult each other as regard the overall implementation of the comprehensive capability building program for the staff and members of the SHADOW ARTS THEATER ORGANIZATION (SATO), Palo, Leyte.

3. The parties shall help each other find appropriate resources and/or materials for the implementation of the Comprehensive Capability Building Program.

## ARTICLE II

#### **PURPOSE**

To establish partnership arrangements that will help develop individually and collectively all the members of the SHADOW ARTS THEATER ORGANIZATION (SATO) as well as its host community through convergent strategy.

#### ARTICLE III

## AREAS OF COOPERATION

## A. SHADOW ARTS THEATER ORGANIZATION (SATO) shall:

- 1. Identify project beneficiaries in coordination with the SHADOW ARTS THEATER ORGANIZATION (SATO).
- 2. Submit list of project beneficiaries to the DEPARTMENT OF CHEMISTRY of the COLLEGE OF ARTS AND SCIENCES EASTERN VISAYAS STATE UNIVERSITY (EVSU) as basis for attendance checklist and performance evaluation test;
- 3. Provide logistical support for the implementation of the project.
- 4. Provide food and accommodation for the trainers.
- 5. Provide/Procure training materials for the training programs;
- 6. Facilitate implementation of the project;
- 7. Monitor project beneficiaries and strictly ensure regular attendance throughout the training course;
- 8. Provide a suitable Training/demonstration room/venue which will accommodate at least twenty (20) participants; Together with the EASTERN VISAYAS STATE UNIVERSITY (EVSU) Faculty.

## B. EASTERN VISAYAS STATE UNIVERSITY (EVSU) shall:

1. Provide available skills and technical manpower resources to the SHADOW ARTS THEATER ORGANIZATION (SATO) whenever required by the latter's entrepreneurship program and projects.

#### ARTICLE IV

## **ROLES OF TRAINEES**

- 1. Trainees shall be committed to attend/participate the training process within the duration of training.
- 2. Trainees shall accept and perform tasks and other related assignments related to the training.
- 3. Trainees shall complete tasks, assessments, assignments, etc. that are set by the Trainer/s.

## ARTICLE V

UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

1. It is expressly understood that there will be no employer-employee relationship between the SHADOW ARTS THEATER ORGANIZATION (SATO) and EVSU personnel extending assistance.

2. COLLEGE OF ARTS AND SCENCES - EASTERN VISAYAS STATE UNIVERSITY (EVSU) shall defend and hold the SHADOW ARTS THEATER ORGANIZATION (SATO) and its management, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages caused by the sole negligence of the SHADOW ARTS THEATER ORGANIZATION (SATO) as well as reciprocal obligation.

### **ARTICLE VI**

#### **EFFECTIVITY CLAUSE**

The Agreement shall be effective, valid and binding for (3 years) from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice
