

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at Eastern Visayas State University, Tacloban City, Leyte, Philippines this 20th of May 2022 by and between the **EASTERN VISAYAS STATE UNIVERSITY (EVSU)**, Tacloban City represented by its President, **DR. DENNIS C. DE PAZ**, herein referred to as the **EVSU-MSD**.

and

the **STA. FE STAND ALONE SENIOR HIGH SCHOOL (SFSASHS)** of Sta. Fe, Leyte represented by its School Head, **MILAGROS P. MACASUSI**, herein referred to as **PARTNER SCHOOL**.

WITNESSETH: That

WHEREAS, the Eastern Visayas State University (EVSU) is a higher learning institution mandated to develop the potentialities of Region VIII along four functions of instruction, research, production, and extension services;

WHEREAS, EVSU implements an Extension Services Program across colleges and campuses and in this particular, the Sustainability through Mathematics and Statistics (SUMS) project of the MATHEMATICS AND STATISTICS DEPARTMENT (MSD) of the EVSU-Main Campus, Tacloban City,

NOW, WHEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I. POINTS OF AGREEMENT

1. The parties approved the implementation of the Sustainability through Mathematics and Statistics project of the MATHEMATICS AND STATISTICS DEPARTMENT of EVSU-Main Campus with STA. FE STAND-ALONE SENIOR HIGH SCHOOL.
2. The parties shall consult each other and plan as regard to the total implementation of any activity related to the project.
3. The parties shall help each other source-out resources and/or materials for the programs and projects of the specified area of coverage.

ARTICLE II. RESPONSIBILITIES OF EVSU-MSD

1. The EVSU-MSD shall inform its partner school of its intent to implement extension services program in the area and shall closely coordinate with the development of all arrangements to be made.
2. The EVSU-MSD shall provide the available skills and technical manpower resources that will be involved in its fieldwork activities based on the needs of the development partner and related to the project.
3. The EVSU-MSD shall provide consultancy services for the conduct of research of the development partner.

ARTICLE III. RESPONSIBILITIES OF SFSASHS

1. The personnel of SFSASHS shall inform its constituents of the presence and assistance of EMSD and shall inform their respective responsibilities in the development work.
2. The personnel of SFSASHS shall ensure the safety of EVSU-MSD personnel in the locality.



3. The personnel of SFSASHS shall facilitate in the implementation, monitoring and evaluation of the extension services provided by MSD
4. The personnel of SFSASHS shall provide coordination facility with other technical and fiscal support by allowing the use of necessary equipment available in its territorial jurisdiction in connection with the implementation of the agreed program.
5. The personnel of SFSASHS shall issue certificate of appearance for on-site activities.

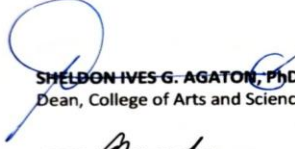
ARTICLE III. EFFECTIVITY CLAUSE

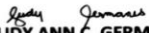
