

MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENT

This **MEMORANDUM OF UNDERSTANDING** made and entered into at Local Government Unit of Carigara Grounds, Carigara Leyte, Philippines on October 20, 2022 between:

The **LOCAL GOVERNMENT UNIT OF CARIGARA** of Carigara, Leyte represented by its Municipal Mayor, **HON. EDUARDO T. ONG, JR.** hereinafter as **LGU CARIGARA**.

The **EASTERN VISAYAS STATE UNIVERSITY CARIGARA CAMPUS** of Carigara, Leyte represented by its Campus Director, **DR. RONALD B. MADERA** hereinafter as **EVSUCC**.

and

The **DISTRICT 5 RADIO AMATEUR NETWORK INC. CARIGARA CHAPTER** of Carigara, Leyte, represented by its Chapter President, **ROMEL T. DANDAN** hereinafter referred to as **RADNET5**.

WITNESSETH:

WHEREAS, EVSUCC is a higher learning institution mandated to develop potentialities of Metro Carigara;


WHEREAS, EVSUCC is mandated to fulfill its four-fold functions, namely, instruction, research, production, and extension services;

WHEREAS, EVSUCC is mandated to implement extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, LGU CARIGARA and RADNET5 are enjoined to develop linkage and networking with academic and other institutions to meet its goal of improving its operation for better services to its constituents;

WHEREAS, LGU CARIGARA under the Department of Interior and Local Government aims to strengthen local government capability to effectively deliver basic services to the citizenry. Thus, there is a need to engage in a meaningful partnership with **EVSUCC** primarily for technical skills assistance and consultancy.

WHEREAS, RADNET5, a volunteer organization that provides emergency disaster management services and community support aims to foster strong partnership and shared responsibility with all stakeholders, and thus in need of linkage with the local government and the academe to ensure the sustainability of the programs it carries.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby and stipulate.

A. RESPONSIBILITIES OF EVSUCC

1. **EVSUCC** shall assist the partner organizations in the creation of information, education and communication (IEC) materials; provide food additives for healthy meal preparation; and technical manpower resources to **LGU CARIGARA** and **RADNET5** whenever required by the latter's health and wellness program;
2. Inform **LGU CARIGARA** and **RADNET5** of any supplies or materials required by its personnel in the conduct of skills and technical assistance trainings;
3. The **EVSUCC** shall inform the **LGU CARIGARA** and **RADNET5** of possible and potential program of the University related to operations improvement, and good governance;

B. RESPONSIBILITIES OF LGU CARIGARA

1. Inform and coordinate with **EVSUCC** and **RADNET5** the conduct of operation improvement, and health and wellness programs that will require their technical assistance;
2. **LGU CARIGARA** shall ensure the availability of supplies and/ or materials to be used by **EVSUCC** personnel and **RADNET5** when extending skills training and technical assistance in conducting health and wellness activities; and
3. **LGU CARIGARA** shall ensure the security of the skills and technical manpower resources sent by **EVSUCC** and **RADNET5** to any of the program and projects implemented by **LGU CARIGARA**.



C. RESPONSIBILITIES OF RADNET5

1. Coordinate with **LGU CARIGARA** and **EVSUCC** the conduct of operation improvement, and health and wellness programs that will require necessary technical assistance from partner organizations;
2. Provide a mobile kitchen in the conduct of operation.

3. Provide emergency response, if the need arises for the duration of the activity.

D. THE FOLLOWING POINTS OF UNDERSTANDING ARE INCLUDED:

1. The parties approved the implementation of the *Hataw para sa Kalusugan Program* of the LGU CARIGARA;
2. The parties shall consult each other as regard to the total implementation of the program;
3. The parties approved the implementation of the extension services program of EVSUCC; and
4. The parties shall help each other source out resources and/or materials for the program.

E. EFFECTIVELY

The Agreement shall be effective, valid and binding for **three (3) years** from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Understanding. Nothing may prevent any of the contracting parties from terminating this Understanding for any justifiable reason upon fifteen (15) days of notice.


