The EASTERN VISAYAS STATE UNIVERSITY – TANAUAN CAMPUS (EVSUTC), a government agency duly created under the laws of the Republic of the Philippines, with office address at Brgy. San Miguel, Tanauan, Leyte, herein represented by its University President, DR. DENNIS C. DE PAZ, hereinafter referred to as UNIVERSITY PRESIDENT;

and

The AMANLURAN BARANGAY COUNCIL with its principal office at Barangay Amanluran, Tanauan, Leyte, herein represented by its Barangay Chairman, HON. LOURDES B. MONTE, hereinafter referred to as COMMUNITY PARTNER.

WITNESSETH:

WHEREAS, the EVSU-TC is a higher learning institution mandated to develop the potentialities of Region VIII.

WHEREAS, the EVSU-TC is mandated with four major functions, instruction, research, production, and extension services;

WHEREAS, the EVSU-TC implemented the TECHNOLOGY TRANSFER, ADVANCEMENT and AWARENESS, TECHNIQUES, ADVOCACY AND KNOWLEDGE CREATION (TATAK) program, an extension services program of the Engineering Department and in this particular the programs/courses of:

Bachelor of Science in Civil Engineering (BSCE) Bachelor of Science in Electrical Engineering (BSEE) Bachelor of Science in Information Technology (BSIT)

WHEREAS, the TATAK Program includes Technology Transfer through CE, EE, and IT Proficiency, Advancement and Awareness of Community on Environmental Protection, Strategies in Alleviating Community Problems, Advocacy on Safety and Health, Knowledge Creation and Innovation of Livelihood through Engineering and Information Technology Approach and the latter covers the conduct of Research Work/Activities for dissemination and or improvement of Extension Services delivery.

WHEREAS, the TATAK Program includes three projects:

Project IT2CoDe: Information Technology Innovation and Training for Community Development (Bachelor of Science in Information Technology)

Project CivilCare: Enhancing Community Resilience through Safety and Environmental Awareness and Skills Development (Bachelor of Science in Civil Engineering)

Project FOCUS: Facilitating Opportunities for Community Uptake and Sustainability through Skills Development, Electrical Awareness, and Environmental Responsibility (Bachelor of Science in Electrical Engineering).

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

ARTICLE I POINTS OF AGREEMENT

- 1. The parties approved the implementation of the Extension Services Program of the EVSU-TC at Barangay Amanluran, Tanauan, Leyte;
- 2. The parties shall consult each other concerning the total implementation of any fieldwork activities;
- 3. The parties approved the implementation of the TATAK Program with its Projects of the EVSU-TC; and
- 4. The parties shall help each other source out resources and/or materials for programs and projects of the barangay.

ARTICLE II RESPONSIBILITIES OF EVSU-TC

- The EVSU-TC shall inform its development partners of its intention to implement Research and Development and Extension Services (RDE) projects in the area and shall closely coordinate with the latter of all arrangements to be made.
- 2. The EVSU-TC shall provide the available skills and technical manpower resources that will be involved in its fieldwork activities based on the needs of the community.
- 3. The EVSU-TC shall implement Extension Plans, Programs, and Projects but not limited to the implementation of the TATAK Extension Program of the Campus.
- 4. The EVSU-TC shall implement the Project IT2CoDE, Project CivilCare, and Project FOCUS under the TATAK Program for one (1) year period with the following activities:

Project IT2CoDe

- 4.1 Conduct various computer literacy training; and
- 4.2 Development, deployment, implementation, and transfer of technology.

Project CivilCare

- 4.3 Solid Waste Management Training related to Civil Engineering;
- 4.4 Conduct technical skills training related to Civil Engineering (e.g. Plumbing, Masonry); and
- 4.5 Safety, Health, and Environmental Awareness.

Project FOCUS

- 4.6 Solid Waste Management Training Related to Electrical Engineering;
- 4.7 Conduct technical skills training related to Electrical Engineering (e.g. EIM);
- 4.8 Electrical Awareness and Environmental Responsibility Training.
- The EVSU-TC shall further in writing the other party regarding the progress of the programs.

ARTICLE III

RESPONSIBILITIES OF THE TARGET COMMUNITY BENEFICIARY

- The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Amanluran, Tanauan, Leyte shall assist/ facilitate in the implementation/ monitoring of the RDE Services and TATAK Program;
- 2. The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Amanluran of Tanauan, Leyte shall assure the safety of EVSU-TC personnel and students in the locality;

- The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Amanluran of Tanauan,
 Leyte shall take charge of providing the needed supplies/ materials if available for the RDE
 Workers and issue certification after completion of programs and projects.
- 4. The Stakeholders/ Beneficiaries/ Barangay Officials of Brgy. Amanluran of Tanauan, Leyte shall allow the use of necessary equipment available in its territorial in connection with the implementation territorial jurisdiction in connection with the implementation of the agreed programs or projects.

ARTICLE IV EFFECTIVITY

The agreement shall be effective, valid, and binding for one (1) year from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon by the contracting parties that such revision or modification is consistent with the original intent and purpose of this agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice of intent.
