

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This **MEMORANDUM OF AGREEMENT** made and entered into at Tacloban City, Philippines on February 4, 2018 by and between;

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DOMINADOR O. AGUIRRE, JR.**, hereinafter as **EVSU**;

And

The **BARANGAY OFFICIALS AND THE RESIDENTS OF BRGY. 83, PARAISO, SAN JOSE, TACLOBAN CITY** represented By its Barangay Chairman **HON. MICHAEL DE VEYRA**, hereinafter referred to as the **DEVELOPMENT PARTNER**,

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement an extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, the DEVELOPMENT PARTNER would like to implement an **ECO TOURISM DEVELOPMENT PROGRAM** in their locality as part of their rehabilitation initiatives and provide livelihood and income to their constituents;

WHEREAS, the DEVELOPMENT PARTNER would like to promote and advocate a sustainable environmental program which can become a model to other communities in the City of Tacloban;

WHEREAS, the DEVELOPMENT PARTNER in its intention of providing livelihood and job opportunities to their constituents engage in meaningful partnership with **EVSU** for technical assistance, livelihood skills development and consultancy;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:



A. RESPONSIBILITIES OF EVSU

1. **EVSU** shall provide technical assistance from the College of Architecture and Allied Discipline in the preparation of the Architectural Design of a Boardwalk to be integrated in the existing Mangrove Plantation Project of the Barangay (i.e. boardwalk design, floor plan, elevation perspectives, etc..)
2. **EVSU** shall provide technical assistance from the College of Engineering in the preparation of the Structural design aspects of the Boardwalk;
3. **EVSU** shall provide technical assistance from its Environmental Science Department of the College of Arts and Sciences for the Environmental Phase of the Project;
4. **EVSU** shall provide other needed relevant assistance through the Office of the Extension Services,(i.e.,provide livelihood skills training to identified sectors in the community;

B. RESPONSIBILITIES OF THE DEVELOPMENT PARTNER


1. **THE DEVELOPMENT PARTNER** will coordinate with **EVSU** regarding the provision of appropriate technical assistance needed for the Eco-Tourism Development Program activity of the community;
2. **THE DEVELOPMENT PARTNER** shall provide counterpart manpower, personnel, materials and other necessary logistical support to assist **EVSU** in said partnership;
3. **THE DEVELOPMENT PARTNER** shall provide **EVSU** with the necessary equipment like welding machine, gas range and other resources available in the locality in its territorial jurisdiction in connection with the program implemented.

C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

1. The parties approved the implementation of the Extension Services Program of **EVSU** in collaboration with appropriate Colleges in its main campus in Tacloban City;
2. The parties shall consult each other as regard the over-all implementation of program.

D. EFFECTIVITY

The Agreement shall be effective, valid and binding for 2 years from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of the provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
