# Section 1. GENERAL POINT OF AGREEMENT:

- 1.1 The parties agree to hold the EVSU College of Business and Entrepreneurship Extension Programs;
- 1.2 The parties agree to pool resources together to support the Eastern Visayas State University Extension Programs for the benefit of the beneficiaries;

# Section 2. DUTIES AND RESPONSIBILITIES

## 2.1

#### The FIRST PARTY shall:

- 2.1.1 Provide orientation and technical training for the TVET beneficiaries with their available resources both in human and venue etc.;
- 2.1.2 Make a need assessment of the students before deployment / graduation;
- 2.1.3 Provide mechanism for the evaluation of the program as well as its participants;
- 2.1.4 Assign a capable instructor(s) with the following duties:
  - a. Conduct an orientation seminar prior to the community engagement;
  - b. Assign manpower to the secondparty as coordinator;
  - c. Monitor activities of the said engagement;
  - d. Collect evaluation forms from the participants in any activities engage from the second party.
- 2.1.5 Issue a certificate of recognition, commendation and participation signed by the EVSU President, VP, OPREDEXs, Extension Director the Second Party.

# The SECOND PARTY shall:

- 2.2.1. Provide the necessary training needs and whatever resources in the area of activities;
- 2.2.2. Provide the data of all beneficiaries of any undertaken by both parties;
- 2.2.3. Assign a capable coordinator with the following duties:
  - a. Conduct a close coordination to the first party'
  - b. Introduce the first party representative to the community where the activities will be done;
  - c. encourage the beneficiaries to participate the activities of both parties.
- 2.2.4. Ensure the safety and security of the First Party;
- 2.2.5. Evaluate the progress of the beneficiaries;
- 2.2.6. To share whatever learning & gain to uplift the life of those who needs

Section 3. **PRE-TERMINATION**. Failure on the part of any party to this agreement to strictly comply with the terms and conditions embodied herein shall constitute a ground for suspension or termination of this Agreement by the other party.
