This **MEMORANDUM OF AGREEMENT** made and entered into at Tacloban City, Philippines on _____ by and between

The **EASTERN VISAYAS STATE UNIVERSITY** of Tacloban City represented by its President, **DR. DOMINADOR O. AGUIRRE, JR.**, hereinafter referred to as **EVSU**

And

The **NORTHERN TACLOBAN CITY NATIONAL HIGH SCHOOL (NTCNHS)**, represented by its **SCHOOL HEAD MR. LUISITO ADRALES**.

And

The **VOLUNTER FOR THE VISAYAN**, represented by its Area Director, **MS. HELENA CLAIRE CANAYONG**.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution of the Republic of the Philippines mandated to develop the potentialities of Region VIII;

WHEREAS, EVSU performs the four major functions of Research, Instruction, Production and Extension Services;

WHEREAS, a part of its function is to implement Extension programs and projects to promote an identified community they establish and development partnerships with other agencies and linkages.

WHEREAS, the NTCNHS and VIV is enjoined to develop partnership with academic and other institutions to fulfill its goal of providing livelihood skills training ~~and other related endeavors to the students.~~

WHEREAS, the NTCNHS and VIV in its effort of enhancing the Provisions of Technical services to community is engaging in a partnership with the Eastern Visayas State University also referred to in this document as EVSU

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and stipulate:

A. RESPONSIBILITIES OF EVSU

1. The EVSU shall provide technical assistance as requested by NTCNHS;

3. The EVSU shall allow its technical person to conduct a periodic supervision during the construction process;

B. RESPONSIBILITIES OF THE NTCNHS & VSV

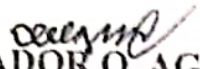
- ~~1. Shall coordinate with EVSU in the gathering of data necessary for the design;~~

3. The NTCNHS shall ensure the security of the technical manpower resources sent by EVSU.

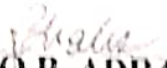
C. EFFECTIVITY

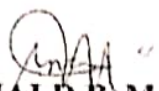

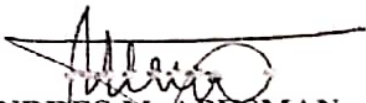
