This **MEMORANDUM OF AGREEMENT** made and entered into at Tacloban City, Philippines on October 31, 2018 by and between.

The EASTERN VISAYAS STATE UNIVERSITY of Tacloban City represented by its President, DR. DOMINADOR O. AGUIRRE, JR., hereinafter as EVSU

The PHILIPPINE NATIONAL POLICE – REGIONAL COMMUNICATIONS AND ELECTRONICS OFFICE 8 of Palo, Leyte, represented by its Chief, PCINSP MARCIANO M. TUBALLAS, JR., hereinafter referred to as PHILIPPINE NATIONAL POLICE – REGIONAL COMMUNICATIONS AND ELECTRONICS OFFICE 8.

WITNESSETH:

WHEREAS, EVSU is a higher learning institution mandated to develop potentialities of Region VIII;

WHEREAS, EVSU is mandated with four major functions, the instruction, research, production and extension services;

WHEREAS, EVSU is mandated to implement extension services program to its immediate communities and to its development partners and identified clients;

WHEREAS, the Philippine National Police – Regional Communications and Electronics Office 8 is enjoined to develop linkage and networking with academic and other institutions to meets its goal of improving its operation for a better services to its constituents:

WHEREAS, the Philippine National Police – Regional Communications and Electronics Office 8 in its intention of satisfying the production operation to cater the needs of the customers, and optimizing the resources provided by the Government, there is a need to engage a meaningful partnership with EVSU for technical skills assistance and consultancy specifically, but not limited to on the field of Information Technology.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby and stipulate.

A. RESPONSIBILITIES OF EVSU

 The EVSU shall provide available skills and technical manpower resources to the IT Department whenever required by the latter's good governance and projects;

- Inform Philippine National Police Regional Communications and Electronics
 Office 8 of any supplies or materials required by its personnel in the conduct
 of skills and technical assistance.
- 3. The EVSU shall inform the Philippine National Police Regional Communications and Electronics Office 8 of possible and potential program of the University related to operations improvement, and good governance;


B. RESPONSIBILITIES OF THE PHILIPPINE NATIONAL POLICE – REGIONAL COMMUNICATIONS AND ELECTRONICS OFFICE 8

- Inform and coordinate with EVSU the conduct of operation improvement, good governance, and projects that will require necessary technical assistance from EVSU;
- The Philippine National Police Regional Communications and Electronics
 Office 8 shall ensure the availability of supplies and/ or materials to be used
 by the EVSU personnel when extending skills and technical assistance to IT
 activities.
- The Philippine National Police Regional Communications and Electronics
 Office 8 shall ensure the security of the skills and technical manpower
 resources sent by EVSU to any of the program and projects implemented by
 the IT Department.

C. UNDER THIS AGREEMENT, THE FOLLOWING TERMS AND CONDITIONS ARE LIKEWISE INCLUDED:

- It is expressly understood that there will be no employer-employee relationship between the Philippine National Police – Regional Communications and Electronics Office 8 and EVSU personnel extending assistance. No compensation shall be paid to the latter;
- 2. EVSU shall defend, indemnify and hold the Philippine National Police Regional Communications and Electronics Office 8 its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, loss or suits including attorney fees, arising out of or resulting from the acts, errors or omissions of EVSU personnel in the performance of this Agreement, except for injuries and damages cause by the sole negligence of the IT Department.

D. EFFECTIVELY

The Agreement shall be effective, valid and binding for five (5) years from the date of signing by the contracting partners without prejudice to the revision or modification of any or some of provisions which may hereinafter be agreed upon the contracting parties that such provision or modification are consistent with the original intent and purpose of the Agreement. Nothing may prevent any of the contracting parties from terminating this Agreement for any justifiable reason upon fifteen (15) days of notice.
