This bulletin is being issued to revise/clarify certain portions of the bidding documents. This shall form an integral part of the bidding document for the above-mentioned procurement project.

QUERIES/REFERENCE	AMENDMENTS/CLARIFICATIONS
Will the procurement be awarded per lot or as an entire project?	The Project shall be awarded as one (1) project comprising two (2) lots, which shall be awarded as separate contracts per lot: Lot 1, with an Approved Budget for the Contract (ABC) of Php3,300,000.00; and Lot 2, with an ABC of Php2,400,000.00. In the event that more than one (1) lot is awarded to the same bidder, a single (1) contract covering all awarded lots may be executed.

ITB Clause 26.5(a)  Partial bid is not allowed. The goods are grouped in a single lot and the lot shall not be divided into sub-lots for the purpose of bidding, evaluation, and contract award.  In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.	ITB Clause 26.5(a)  <b>Partial bids are allowed. All Goods are grouped in lots listed below. Bidders shall have the option of submitting a proposal on any or all lots and evaluation and contract award will be undertaken on a per lot basis. Lots shall not be divided further into sub-lots for the purpose of bidding, evaluation, and contract award.</b>  In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.
May the term "Deluxe" be removed from the project title while retaining "2.8," considering that the posted specifications do not correspond to a deluxe variant?	Please see Annex "A" for the amended Technical Specifications.
May alternative specifications for Lot 2 be proposed to accommodate the offered model?	The Committee unanimously agreed to retain the original specifications as stipulated in the posted PBD.
Are leather seat covers and similar features required under the specifications for Lot 2?	The Committee confirmed that these features are required for Lot 2.
May the Committee accept an Official Receipt (OR) in lieu of the Mayor's Business Permit, given that the permit is still under processing despite payment having been made?	The Committee clarified that while the OR may be accepted during the Bid Opening, the approved Business Permit must still be submitted during post-qualification.
